KDOT COST SHARE PROGRAM

The Kansas Department of Transportation Cost Share Program is preparing for it's fall funding that Kansas municipalities can apply for. All transportation projects are eligible, including roadway (on and off the state system), rail, airport, bicycle/pedestrian and public transit. 2022 SURVEY OF MUNICIPAL COURT PRACTICES

The League launched the 2022 Survey of Municipal Court Practices last week. The goal of the survey is to allow cities to see how their fines for certain offenses compare to other municipal courts around the state and update practices. The survey seeks to collect the following data:

- Fines and Fees
- Indigency

• Municipal Court Salaries

- Enforcement
- Municipal Court Staff and Hours

When possible, the League sent direct links to the survey to municipal court clerks. For cities who did not have a municipal court clerk listed in the League's directory, we sent links to city clerks. Please contact Wendi Stark if your municipal court has not received a link to the survey. The deadline to complete the survey is July 1, 2022.

KANSAS HOUSING RESOURCES CORP. HOME-ARP LISTENING SESSIONS

The final listening sessions for Kansas Housing Resources Corporation's (KHRC) HOME-ARP Program are being held on June 28 and June 29, 2022. The writing of the Allocation Plan began earlier this year, and this will be the final opportunity for State and local partners to share data directly with our organization and our consultants before the HOME-ARP Allocation Plan is completed. Any comments following these sessions must be made in writing.

FEDERAL MILEAGE RATE INCREASE

As cities are in the midst of preparing 2023 budgets, please be aware that the IRS raised the standard mileage rate from 58.5 cents per mile to 62.5 cents per mile. This rate becomes effective July 1, for the final six months of 2022. *Click here for more information*.
