Get to know LPA members with our series, "Coffee Talks" where we meet pharmacists, pharmacy technicians, and students who are making an impact in pharmacy and their communities.

Getting to know Minh Nguyen, RPh

Minh is the middle of seven children and born in Viet Nam. His family moved around the states until settling in Houma in '78. Despite his father's push to shrimp boats, and a short dream of being an aviator (a la Top Gun), Minh entered pharmacy school. After graduating, he came back to Houma and would learn many lessons as he worked in different retail settings before opening his own pharmacy. (He says that was the best decision his wife made for him). In 2011, Willow Bark Pharmacy #1 was born and Minh felt such a sense of freedom and loved his job even more as an independent owner, seeing so much more in the world of



pharmacy. He learned about the business side of pharmacy and got involved with state and national organizations advocating for the profession with the Legislature and Congress. "To this day, I still love my job; it's just a little tougher. But I'm doing it because of the people I serve and the future of our profession."

What advice do you have for recent pharmacy graduates?

No matter what type of pharmacist you are, stay in touch with our professional state and national organizations. Be aware of what goes on in our profession - it is constantly evolving. Also be humble and call on other pharmacists when you need advice. My first day as a licensed pharmacist, I was the only pharmacist with one tech and one clerk, worked a 12hour shift, 300 plus prescriptions. I had worked before with other pharmacists, but it's not the same until you actually have to make real world decisions on your own. I called a trusted pharmacist and for a few years he was my "go to" guy.

What do you see as the best and worst changes in pharmacy?

The best change in pharmacy would be medication administration. In retail pharmacy, it allows us to provide services quickly and it's definitely within our scope of practice. Being able to provide immunizations to the public is good for everyone.

The worst change in pharmacy is allowing insurance companies to interfere with treatment plans. Early in my career, an elderly woman came to the pharmacy while her husband, just released from the emergency room, sat in the car. She presented a prescription for Cipro tablets. His insurance rejected as "not covered, non-formulary." They only covered Levaquin which at the time, was a brand drug. It was Friday afternoon, the doctor was gone for the day, and emergency rooms don't do prior authorizations. The wife paid cash for the Cipro because her husband needed it. What good is insurance if it can't cover a generic drug? What makes insurance companies more qualified than prescribers?

What concerns you most about the pharmacy profession?

PBMs concerns me the most and we desperately need national reform. The Federal Trade Commission needs to work harder to give small independent businesses a fighting chance. The PBMs' vertical integration chokes out any chance for pharmacies to make a profit. Their ever-changing, metamorphosing spread pricing is

relentless. Our profession is not as alluring as it was 15 to 20 years ago with incoming classes becoming smaller and smaller. Everything ties in together and is related.

What is the most memorable event in your career?

The most memorable event in my career would have to be the Covid-19 Pandemic. It was a very scary time. We were in the dark and all terrified of the unknown. So much information floating around but we did our best and lived through it. With the help of LIPA, both of our pharmacy locations were chosen to spearhead the vaccine roll-out in Terrebonne and Lafourche Parishes. Our staff stepped up and worked tirelessly to vaccinate the public and give them peace of mind. We were very relieved to provide the service and felt our true purpose as providers and auxiliary personnel.

What do you do when you're not working?


Catching up on work! The two locations keep me busy. I love to spend time with my wife, kids, and grandkids (so many personalities). Spending time together or just a simple outing is good enough for me. I would like to find more time for golfing and saltwater fishing. It's been over 20 years since I played golf when I used to play 2-3 times a week. I picked up the clubs again last year for the first time—what a feeling!

What is the best thing about being a part of LPA?

Being a part of LPA gives me a chance to share what I have learned throughout my career. I hope to be involved for a long time so I can contribute and help in any way. I am at a point in my life where I can devote time to many organizations.

If you could have one wish came true for pharmacy, what would it be?

Middlemen (PBMs) going back to processing claims and not abusing formularies and the prior authorization process. Rebates and benefits must be passed on to the patients and employer groups. Pay pharmacies cost plus x amount, that way we can all go back to being pharmacists doing our job to the best of our abilities.

The Louisiana Pharmacists Association invites pharmacists, pharmacy students, and pharmacy technicians to present an educational poster during the Annual Convention! Our call for poster abstracts is now open through May 1, 2025.

Poster Topics

The topics of your poster should be relevant to current pharmacy subject matters, including specialty areas and all practice settings. Topics must meet one of the ACPE approved Topic Designators:

- Disease State Management / Drug Therapy (drugs, drug therapy, and/or disease states)
- AIDS Therapy (therapeutic, legal, social, ethical, or psychological issues related to understanding and treatment)
- Law Related Pharmacy Practice (federal, state, or local laws and/or regulations affecting the practice of pharmacy)
- General Pharmacy (topics relevant to the practice of pharmacy other than those included in the above three designators)
- Patient Safety (topics relevant to the prevention of healthcare errors and the elimination or mitigation of patient injury caused by healthcare errors)
- Immunizations (recommended immunization schedules, administration procedures, proper storage and disposal, record keeping, adverse drug events, first aid, general updates
- Compounding (sterile, non-sterile, hazardous drug compounding for humans and animals, best practices, USP quality assurance standards)
- Pain Management (treatment and management of pain, prescribing and distribution and use of opioid medications, opioid addiction and misuse)

Requirements for Abstract Submissions

Abstracts will be accepted online. Please be prepared to provide the following information when submitting. Only complete submissions will be considered for inclusion in the final poster session.

- Poster Title
- · Author(s) name and credentials
- Topic Designator (from #1-8 above)
- 2-3 objectives for the learner (must be measurable, beginning with words such as "describe," "explain," "outline," "define," etc.)
- Written abstract (300 word limit) which includes the following elements:
- Introduction / Statement of Issue or Problem being addressed
- · Materials and methods used
- Results
- Conclusions
- · Relevant References

In addition, you will be asked to agree that no authors involved have any commercial interest or bias contained within the intended poster presentation. This is required for ACPE approval.

Notification of selections will be sent by May 31, 2025.

Selected abstracts are expected to have a prepared poster and have at least one author in attendance to present the poster on the specified time(s) designated on the agenda.




