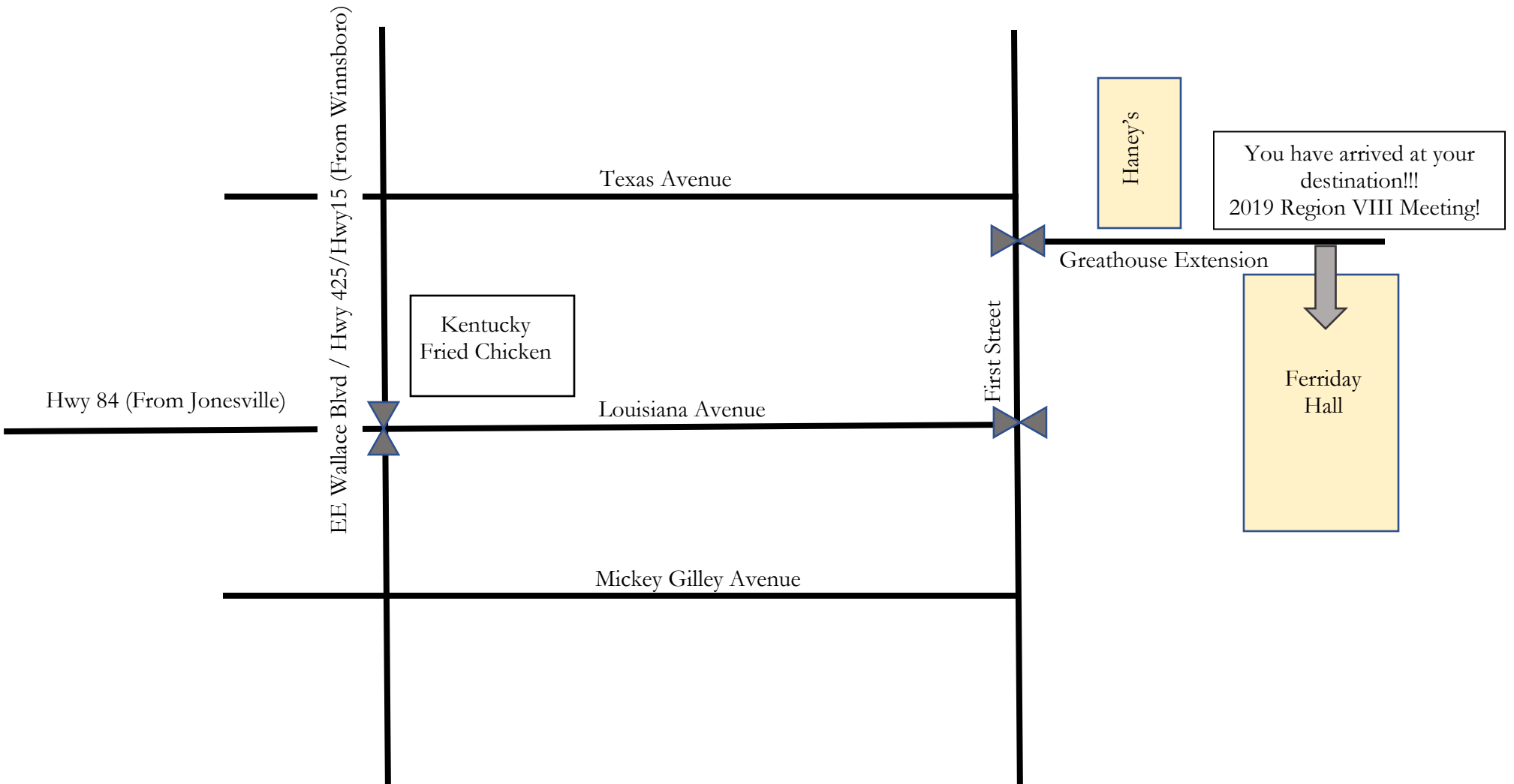

DIRECTIONS!

From Jonesville: Stay on Hwy 84 until you reach Ferriday. At the intersection of Hwy 425 (EE Wallace Blvd) and Hwy 84 (Louisiana Avenue), stay STRAIGHT until Louisiana Avenue dead ends at First Street. Take a LEFT at the red light. Venue will be one block down on your RIGHT.

From Clayton/Winnsboro: Stay on Hwy 425 until you reach the red light at the intersection of Hwy 425 and Hwy 84. There will be a Kentucky Fried Chicken on your left. Take a LEFT at the red light onto Louisiana Avenue. Stay on this street until it dead ends. Turn LEFT onto First Street at the red light. Venue will be one block down on your RIGHT.
