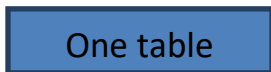

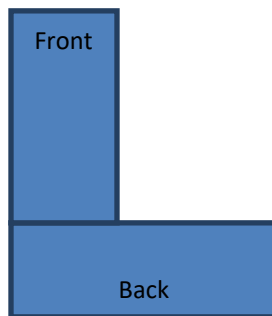

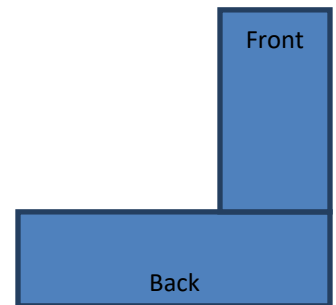
LSHA EXHIBITOR TABLE LAYOUT Configurations are made with 6 ft. tables



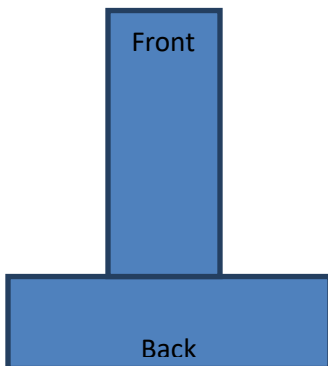

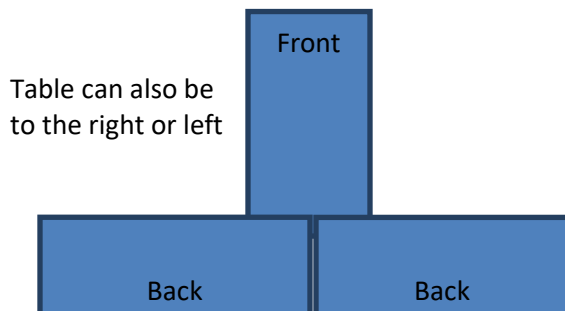
