

## Law Day 2019 Essay Contest: Free Speech, Free Press, Free Society

The Maine State Bar Association invites all Maine students in grades 9-12 to participate in its Law Day essay contest. Established by President Dwight D. Eisenhower in 1958, Law Day honors the rule of law. Law Day, which is held annually on May 1, provides an opportunity to understand how law and the legal process protect our liberty, strive to achieve justice, and contribute to the freedoms that all Americans share.

**Law Day Theme:** The 2019 Law Day theme – Free Speech, Free Press, Free Society – focuses on these cornerstones of representative government and calls on us to understand and protect these rights to ensure, as the U.S. Constitution proposes, “the blessings of liberty for ourselves and our posterity.” In the United States and around the world, freedom of speech and the press are among the most important foundations for a free society. Free speech and free press are prominent topics in public discourse and litigation. It is impossible to imagine a free society without these individual liberties, yet historical and current debates surrounding them continually challenge us to consider their boundaries and resilience. Changes in technology have reshaped how free speech and free press work in the everyday world. Law Day 2019 offers the opportunity to explore this pair of freedoms by probing their history and considering their future. Should all speech be “free?” What is the role of government in regulating or protecting the press? Should speech or the press be constrained through laws or norms? Can a free society exist without free speech and free press?

**Essay Prompt:** In the context of the Law Day theme above, discuss how you believe free speech and free press are part of the foundation of a free society, and how these freedoms impact your daily life.

**Eligibility:** This contest is open to Maine students in grades 9-12.

**Criteria:** Entries must be 750-1000 words and typed in a 12-point font. Essays must be submitted with an entry form. **Do not include your name on the essay.** Entries will be judged on accuracy of information, clarity of expression, content, and originality.

**Deadline:** Email or mail essays with entry form to [kholub@mainebar.org](mailto:kholub@mainebar.org) or **Kathryn Holub, Law Day Essay Contest, Maine State Bar Association, 124 State St., Augusta, ME, 04330.** Emailed entries must be received by **midnight on May 15.** Mailed entries must be **postmarked by May 15, 2019,** or they will be disqualified.

**Prizes:** Two winners will be selected. First prize is \$75 and second prize is \$50. The winning students’ teachers will also win \$75 and \$50, respectively. The winning essays will be published in the *Maine Bar Journal* and at [www.mainebar.org](http://www.mainebar.org).
