Note: "Years 1 & 2" and "Years 3 & 4" refer to the number of years that an attorney has been admitted to any bar.

Non-Practicing: \$160/year

Attorneys in good standing,* who reside in the State of Maine but are not engaged in the practice of law.

Non-Resident: \$160/year

Attorneys in good standing,* admitted to the practice of law, who neither reside nor practice in the State of Maine. Non-resident members are not eligible to participate in the MSBA group health or dental insurance programs.

Retired: \$160/year

Attorneys in good standing,* admitted to the practice of law, who reside in the State of Maine and who practice no more than 40 hours per month.

Judicial: \$160/year

Members of the Maine and federal judiciary.

Law Student: Free

Students in good standing,* enrolled in an accredited school of law. Persons are eligible for student membership until admission to any bar or up to one year following graduation from law school, whichever comes first. Student members not residing in the State of Maine are not eligible to participate in the MSBA group health and dental insurance programs. This is a non-voting membership category.
