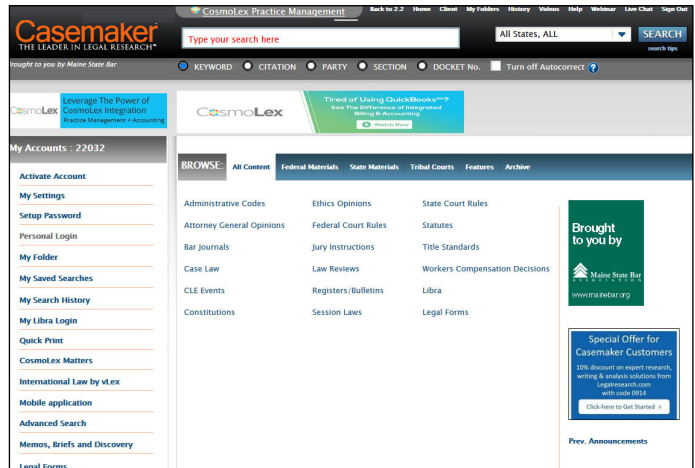

Features and Functionality

MSBA members have access to CasemakerPRO, a suite of premium services included free with membership.

CaseCheck+: A negative citator system that lets you know instantly if the case you're reading is still good law. Returns treatments instantly and lets you link to negative treatments and quickly review the citation history for both state and federal cases.



Upload a brief or pleading and within 90 seconds Casemaker will provide a report stating whether your case citations continue to be good law.

CasemakerDigest[®] Receive daily email or RSS feed summaries of appellate decisions for all state and all federal circuits, categorized by subject.



Mobile App: Take Casemaker with you by loading the App on up to three mobile devices.
