Virtual Environment Workshop Committee 2018 Fall Workshops Summary Report

Background:

For over 28 years, the Minnesota GIS/LIS Consortium has provided GIS professionals and students quality educational opportunities culminating each year at the annual MN GIS/LIS Conference and Workshops. Workshops are taught by members of the Consortium each year providing unique educational opportunities for attendees. In 2017, one workshop was offered that utilized a virtual environment (Amazon Web Services, AWS) for workshop PC's. This was done again for Spring Workshops with the same workshop offered by Kim Sundeen from Lake Superior Consulting.

The Project:

With the success of the 2 previous workshops offered with AWS, the MN GIS/LIS Board of Directors requested up to 4 workshops utilize a virtual environment for the 2018 Fall Conference Workshops. The hope was to streamline the process of providing each student and instructor with an identical environment before and during the workshop day to reduce issues with installations and varying environments on individual PCs. The MN GIS/LIS Conference offered 16 workshops at the 2018 Conference. The GIS Ninjas submitted a proposal for assisting with the setup of the Azure environment, training for the instructors and Consortium representatives, and provided documentation for the Azure set-up. Kim Sundeen and Don Waldo worked on behalf of the GIS Ninjas. The Board agreed to the terms of the proposal.

The Workshops and Virtual Environment committees identified several workshops to utilize a virtual Azure environment to provide student and instructor virtual machines set up specifically for each workshop. The 4 workshops that utilized these services were: **Exploring the New Utility Network using ArcGIS Pro**, Kim Sundeen, Lake Superior Consulting; **An Introduction to QGIS 3**, David Bitner, Boundless Spatial; **Full Stack Application Development**, Caleb Mackey, Bolton & Menk; **Web AppBuilder for ArcGIS: Knowing Your Options**, Chad Nunemacher & Paul Hedlund, Houston Engineering.

Azure cloud services were used and configured by the GIS Ninjas. Kim Sundeen worked with Microsoft to submit a Non-Profit grant for the MN GIS/LIS Consortium. The grant was awarded, and the Consortium used \$261 to date of the grant for the year. This was a total used for the setup and on the workshop day for the 4 workshops. This grant will expire in July 2019. The Consortium can re-apply for the grant each year. Kim Sundeen provided the training on the Azure administration to the workshop instructors and the Consortium representatives about 4 weeks before the workshops. During the workshops, Kim was available all day to help troubleshoot any issues that came up. There were a few issues that Kim was able to work through or find alternative solutions. Workshops volunteers also provided assistance during the workshops. Documentation was also provided by Kim Sundeen for use of Azure for the MN GIS/LIS Consortium account. Overall the experience was a success and could be done again with future workshops.

**Virtual Environment Workshop Committee
2018 Fall Workshops Summary Report**

What we learned:

- Using the Azure lab will simplify the ability to set up the machines for each workshop and improvements are expected by Spring Workshops.
- Instructors are advised to access the Azure lab as early as possible to set up and test their workshops to prevent issues on workshop day. The more involvement by the instructor before the workshop and with the set-up there are fewer issues the on workshop day.
- Offering workshops with a virtual environment seems to work well and could be managed by Consortium representative.
- Identify a person/people/committee associated with the Consortium to provide virtual access for workshops. This could be part of the Workshops committee or another identified person similar to the web master.
- Apply for the Microsoft Azure Non-Profit grant. This basically allowed free use of Azure for the 4 workshops this fall.

Summary:

The MN GIS/LIS Consortium used this as a pilot project to assess using a virtual environment as a method of simplifying workshop machine set-up and providing a positive experience for the workshop instructor and attendees. Few issues were encountered, and the costs were well within budget. Adding the Microsoft Azure Non-Profit grant helped keep costs down and showed that we can offer more workshops with virtual machines. Training of identified Consortium representatives and workshop instructors is essential to the success but can be provided easily. Offering workshops with Azure, AWS or other cloud services worked well and should be considered for future workshops offered by the MN GIS/LIS Consortium.

- The MN GIS/LIS Consortium currently pays for an ArcGIS online account bundled with other ESRI services. It renews at the same time (Sept 19th) as the ESRI license. Cost \$100
- Currently it allows (1) Level 2 (admin) user and 100 credits.
- Because our organization has been accepted within the Nonprofit Organization Program, we are eligible to receive (1) Level 2 Named User + 1,000 service credits for \$100 per user, per year.
- To add Level 1 named users (viewer only levels), these would be \$50 per user, per year.

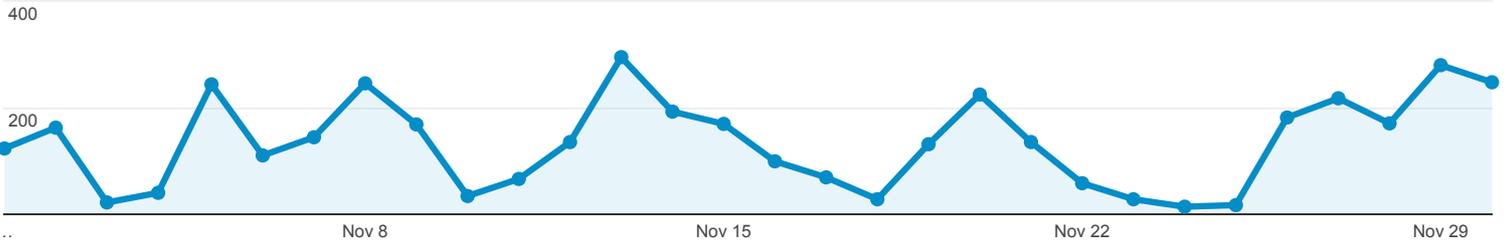
