Legislative

- A number of MHCA priorities were included in the Omnibus Supplemental Budget Bill, which was ultimately vetoed by Governor Dayton. They included:
 - Predatory Offender Notification
 - Home Care Regulations update
 - Electronic Visit Verification

Regulatory

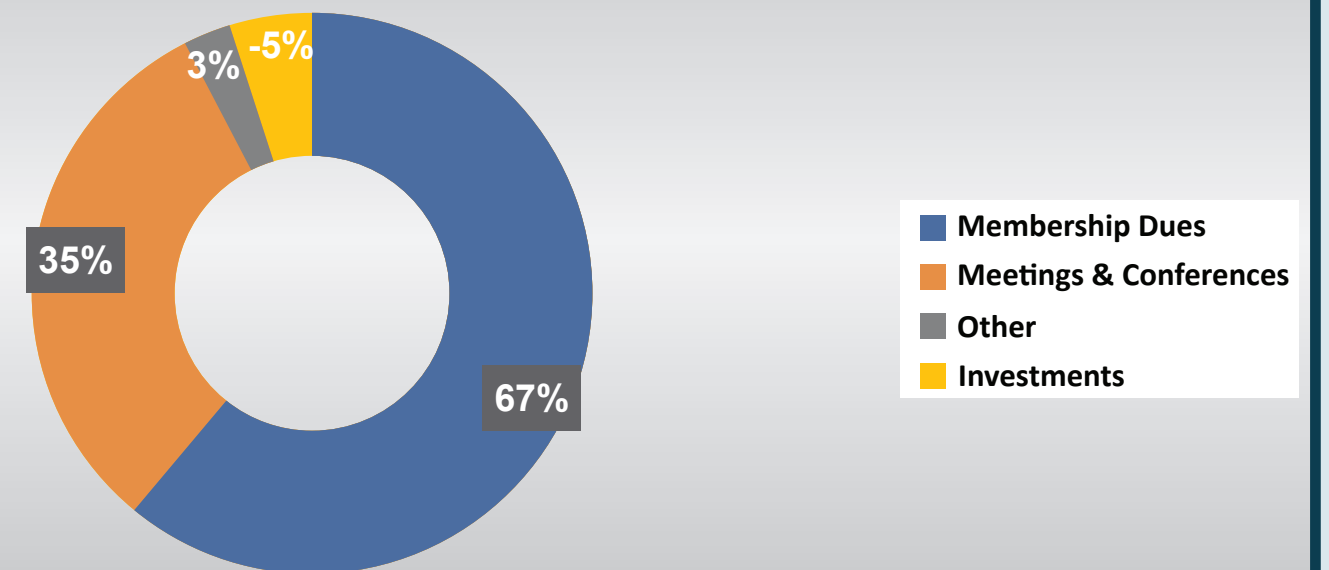
MHCA worked with state regulatory agencies on issues such as:

- Legislative revisions to Comprehensive Home Care License
- Assisted Living licensure
- EVV implementation
- Payment Reform

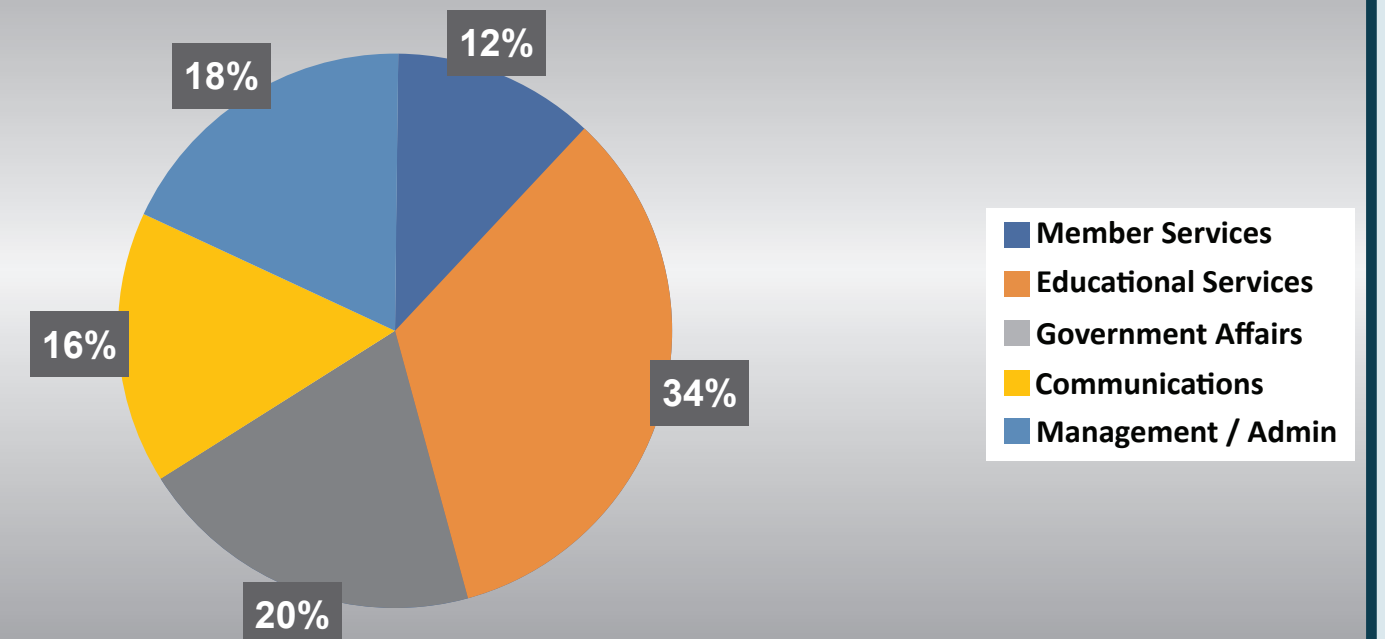
Education

- Offered six educational workshops with total attendance of 381.
- Hosted two annual conferences with a total attendance of 296 conference attendees and 50 exhibitors.
- Launched eight webinars with an attendance total of 435.
- Continued collaboration with LeadingAge MN, providing the Annual Assisted Living & Home Care Conference.
- RCTCLEARN.NET (web- based training)
 - Provided 119 member agencies with active user IDs.
 - 18,391 courses completed with a satisfaction rate of 98%.
 - Issued 33,461 contact hours at a rate of \$0.43 per contact hour.

Where Did MHCA Revenue Go?



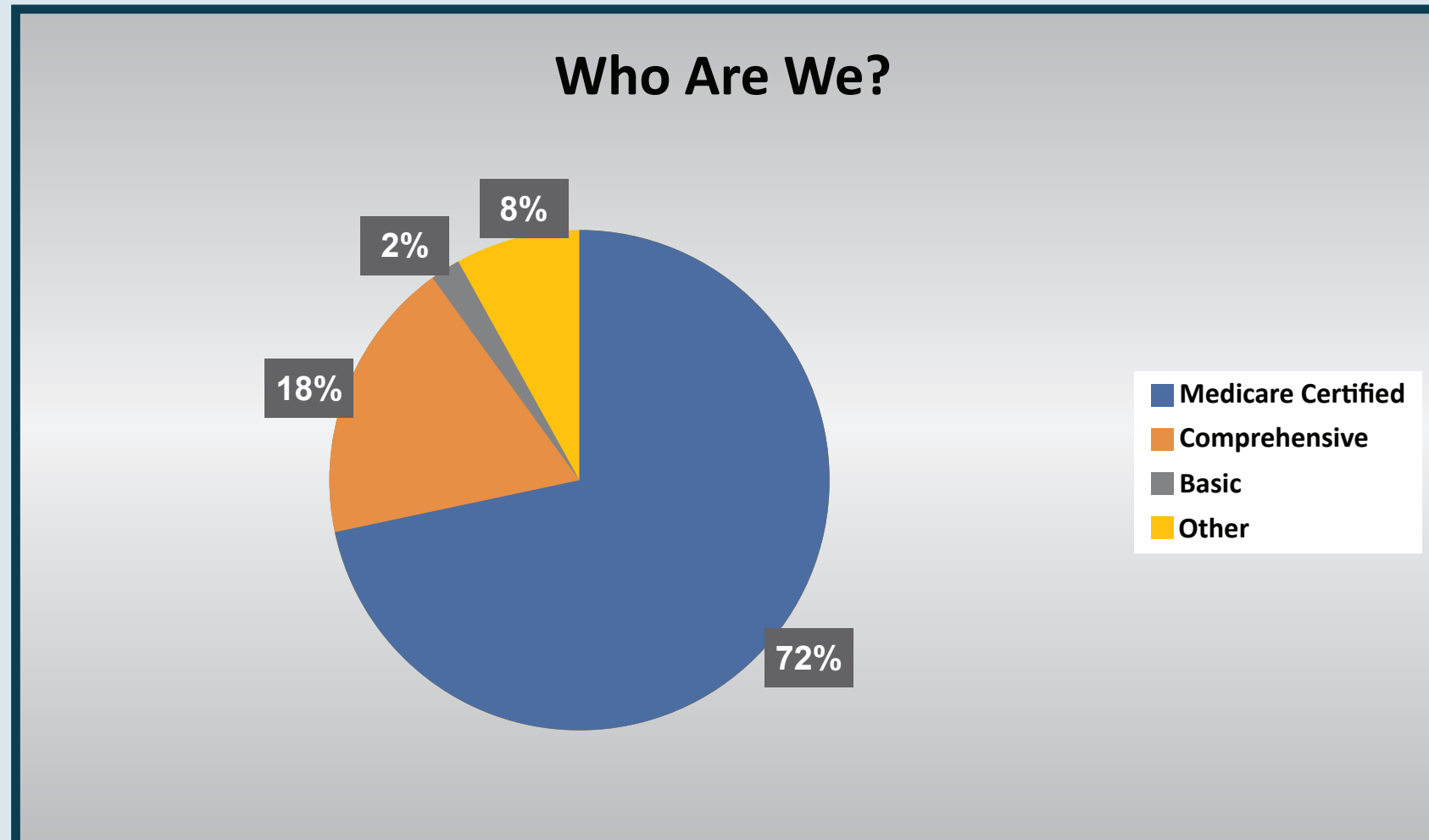
