2011 Montana Pro Bono Reporting Executive Summary April 2012

Data has been collected for **2,302** attorneys. There is a small percentage included in the attorney total that could be determined as something other than "active". This amount is not large enough to be statistically relevant. There are **254 out-of-state** active status attorneys in this total.

There are **3,004** attorneys on "active" status within the state of Montana. The numbers used to calculate hours and percentages were based on the "active" attorney populations excepting the small percentage who indicated something other than active.

Based on the above, about **68% active status in-state Montana attorneys** submitted the 2011 pro bono report (an increase of 10% from 2010). About **43% out-of-state status attorneys** submitted a 2011 pro bono report (matching 2010 reporting). Of the 2,048 <u>in-state</u> status **Montana attorneys** reporting, **1,770** or **85%** reported **110,207** pro bono hours providing services **to persons of limited means or programs designed to assist people of limited means. ¹**

In addition and not included in the hours summarized above, **788** incidents or **39,077 hours** of free or reduced services to charitable, religious, civic, community, governmental or education organizations in furtherance of their organizational purposes, where payment of fees would greatly depleted their economic resources.

The **total number of pro bono hours** reported in 2011 represents more than a **25% increase** in total pro bono hours since 2009.

Of those reporting, about 27% provided services to MLSA (its clients or one of its programs) representing a 6% increase from 2010; 29% provided services to a local or state pro bono program representing a 8% increase from 2010; 31% provided services to a court-based program representing an 11% increase since 2010; and 75% provided services to a self-referred client representing a 7% increase from 2010. The "organized" programs collectively for the first time exceed self-referred percentages by incidents. Because attorneys may have provided services in more than a single category, the percentages are not mutually exclusive. The remainder of reported hours reflects a greater number of direct services to persons of limited means as opposed to organizations designed to assist people of limited means. Direct services continue to increase.

Family law continues to lead the categories of direct service (43.1%). Non-profit (which also includes services to the organization versus directly to individuals served by those organizations) is holding at approximately 25% in the second place. Overall, there is a substantial increase in direct service hours.

Approximately 94% of attorneys reported their pro bono experience was positive or very positive.

¹ Statistics for in-state status are extracted because a relative percentage of out-of-state attorneys do not report and/or do not provide pro bono hours benefiting Montana citizens.
