The Supreme Court of the State of Montana has calendared **TUESDAY, APRIL 30, 2019**, as the date for the swearing-in ceremony for successful February 2019 bar examinees.

If you plan to attend this ceremony, you must notify this office at (406)444-3858 by FRIDAY, APRIL 26, 2019.

The ceremony will commence at **10:00 a.m. in the courtroom of the Montana Supreme Court, located in the Joseph P. Mazurek Justice Building at 215 N. Sanders, Helena, Montana.** Registration will be from 8:45 a.m. to 9:45 a.m. in the Office of the Clerk of the Supreme Court, Room 323 of the Justice Building. If you wish to participate in the ceremony, you must have met all eligibility requirements, including payment of all dues and fees of the State Bar of Montana.

If you cannot attend the April 30, 2019, ceremony, be advised you may petition the Supreme Court to be sworn-in by an authorized judge in another jurisdiction pursuant to the Montana Rules of Admission or you can make arrangements to be sworn-in at the office of the Clerk of the Supreme Court.

At the ceremony, the Montana Attorney General (or his designate) will move for your admission before the Court. If you prefer to have a friend or relative move for your admission, then special arrangements must be made by contacting **Julie James** of the Attorney General's office by April 26, 2019, at (406)444-2026 to designate your movant as a Special Assistant Attorney General. The individual moving your admission must be an active member in good standing of the State Bar of Montana. **The Clerk's office must also be notified of your special movant.**
