SBM - Member List Use Agreement

In addition to the agreements and reservations included elsewhere in this agreement, the SBM and the firm, company or individual whose name and signature appears at the end of this document (user) agree as follows:

The user agrees not to copy or reproduce lists or permit anyone else to copy or reproduce them any format. If the user has someone else affix the addresses to the materials to be mailed, the user will require that the person or company agree not to copy or use the lists for any other purpose. Other than for the limited purpose of affixing the address to the materials to be mailed, the user will not permit the list to pass into the possession of anyone else.

The user will furnish SBM with a copy or sample of all materials or other matter to be mailed in advance of any use of an SBM list.

Notwithstanding any SBM approval, the user will hold SBM harmless against any damages or claim of damage, costs, and reasonable attorney fees, arising out of any actual or allege impropriety or illegality of mailed matter, or infringement of trademark, trade name or copyright belonging to others.

The parties expressly agree that SBM 's rights including, but not limited to, common law and statutory rights of literary property and copyright in the SBM list are not assigned or released as a result of this agreement, but are reserved and retained by SBM subject to the limited use permitted under this agreement.

SBM will try to meet the scheduled delivery of mailing dates but will not be liable for failure to meet requested or scheduled dates.

In addition to any other liability of the user, the user's violation of this agreement shall I subject the user to forfeiture of the privilege of using SBM lists in the future.
