

**AMERICAN MOSQUITO CONTROL ASSOCIATION**  
**BUSINESS MEETING**  
Wednesday, March 5, 2008

**CALL TO ORDER:**

President Gene Payne called the meeting to order at 10:30 AM.

**MOMENT OF SILENCE:**

The President called for a moment of silence for those members who passed away during the year. Members remembered included Taweesak Wuithiranyagool, Ron Finley, Ken Carden, Ted Davis, Evan Lusty, Clarke Hudson, and Cy Lesser.

**APPROVAL OF MINUTES:**

President Payne called for the approval of the minutes of the April 4, 2007, Annual Business Meeting held in Orlando, Florida, which were distributed to all members present.

Bill Opp moved, seconded by Joe Sanzone, that the minutes of April 4, 2007, Annual Business Meeting be approved as presented. The motion was unanimously approved by voice vote.

**PRESIDENT'S REPORT:**

President Payne requested that each AMCA past president stand in order to be recognized. Mr. Payne thanked the AMCA for the honor of serving as president.

**HEADQUARTERS REPORT:**

Sarah Gazi, AMCA Executive Director, presented the Headquarters Report. Ms. Gazi reviewed the current AH staff working on AMCA.

Ms. Gazi announced that 958 people had registered for the 2008 Annual Meeting and compared the registration numbers from 2004-2008.

Ms. Gazi also reviewed exhibit registration from 2004-2008, abstract submissions from 2004-2008, and total membership from 2003-2007.

**TREASURER'S REPORT:**

Allan Inman, AMCA Treasurer, reviewed the 2007 year end financial performance.

Mr. Inman also reviewed the AMCA investments, income vs. expenses for 2006-2007, and announced that we lost \$968 in 2006-2007.

Karl Malamud-Roam presented the Legislative & Regulatory Committee Report at this time because of the financial impact that legislative activity plays into the AMCA finances. Dr. Malamud-Roam discussed the current legislative activity and its impact on AMCA.

Dennis Walette moved, seconded by Stephanie Whitman, that the Treasurer's Report be approved as presented. The motion was unanimously approved by voice vote.

**COMMITTEE ACTIVITY:**

Ms. Gazi introduced Joseph Conlon, Public Relations Committee Chairman.

Mr. Conlon presented the Public Relations Committee report.

Mr. Conlon reviewed the PR efforts that were made for the 2008 Annual Meeting, including the I'm One program.

Ms. Gazi introduced Stephen Sickerman, Chairman of the *WingBeats* subcommittee.

Mr. Sickerman presented Mr. Inman a check in the amount in \$3603.30 for AMCA's portion of *WingBeats* revenue.

Ms. Gazi asked if any other committee chairs would like to present any committee activity to the membership. With no other committee reports presented, Ms. Gazi thanked all AMCA volunteers and committee members for their hard work and commitment to the association.
