



Application for NextGen Workflow and Utilization Review

Overview:

The Michigan Quality Improvement Network (MQIN) is partnering with Ohio Shared Information Services (OSIS) to provide a unique opportunity for Michigan Federally Qualified Health Centers (FQHC) using NextGen as their Electronic Health Record (HER) provider. This partnership enables MQIN to provide a free cost gap assessment of the workflow and utilization of NextGen EPM/EHR to MQIN Health Center members. The goal of this complimentary offer, conducted by OSIS on behalf of MQIN is to conduct a half day on-site EPM/EHR utilization review by a team of OSIS content experts. Utilizing tools and methodologies developed specifically for Health Centers, OSIS automates all technology including program initiatives including Meaningful Use, Patient-Centered Medical Homes, and Population Health.

Too often, a Health Center will make changes or upgrades to technology and the workflows that support the Health Center do not change alongside the upgrades. The utilization review begins with analyzing the current state of the workflow, from check in to check out, to ensure processes are standardized and in alignment with the NextGen EPM/EHR solution in order to take advantage of automation.

Process:

- I. During the on-site review the OSIS consultant team will:
 - Assess Version/KBM state and review overall automation goals and objectives to establish timeline to accomplish optimization initiatives.
 - Evaluate both EPM practice and enterprise settings to ensure organization is aware of and properly utilizing all FQHC specific features.
 - Shadow both proficient and struggling providers to identify risk factors to an optimized clinical deployment and suggest best practice process redesign efforts to reach full adoption.
 - Identify system governance issues and outline the formation of executive, operational, and content core teams/committees to define, communicate, and enforce adoption policy with customized compliance tools.

As a next step, the Health Center will receive an outline of the optimization program to make the most out of your NextGen investment.

Health Center Site Eligibility/Costs for participation

All Michigan Quality Improvement Network (MQIN) members using NextGen are eligible to participate upon submission of application. MQIN has hired OSIS, and will cover all service expenses to offer this service FREE to interested Health Centers. Expected Time/Resource Allocation:

Participating MQIN member Health Centers will be expected to devote a minimal amount of time to complete an application, host the OSIS consultant team for the on-site review, and arrange for the providers to be shadowed. A designated contact will be expected to work with MQIN to schedule the date for the on-site review. A one-week schedule window will be provided to the Health Center. Once the appointment is set, it cannot be rescheduled.
