NACC was founded in 1977, three years after the passage of the Child Abuse Prevention and Treatment Act (CAPTA), the first federal law to require guardian ad litem representation of children in child welfare proceedings. The founders of NACC sought to establish child welfare law and children’s legal representation as a specialty practice, and to provide resources and tools to a growing network of attorneys.

Today, NACC remains firmly committed to making this difficult practice a little easier — by providing all attorneys in the child welfare system training and technical assistance, inspiration and motivation, as well as the opportunity to get involved and improve the system for children and families.

Extra Large (100 or more attorneys)	\$ 8,000
