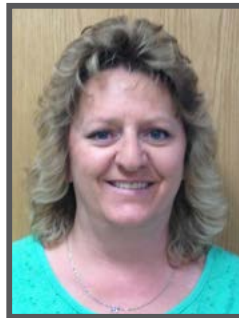


## A Message from the President

# 2016 Excellence in Gaming Regulation Award

Nominations accepted through April 4, 2016

An award is given each year at the NAGRA Annual Meeting to an individual who has demonstrated excellence in the field. A call for nominations is sent to the members of NAGRA near the end of each calendar year and a committee is established to review the nominations and determine a winner.

## Eligibility:

This award is open to regulators who have demonstrated outstanding accomplishments in the gaming regulatory or enforcement environment. All nominees must be current NAGRA members.

## Nomination Process:

Nominations must be in writing. Nominations must include examples of actions/achievements by the nominee. Nominations should include the name of the nominee, title, jurisdiction and contact information.

## Selection Criteria:

The committee will consider nominees who have demonstrated sustained achievement, exceptional performance and deserve recognition for their extraordinary contributions in the field of gaming regulation. Areas of consideration may include:

- The supervision or organization of employees leading to outstanding accomplishments.
- The enhancement of the public perception of gaming regulation by external organizations.
- The identification and implementation of significant cost savings for a specific jurisdiction.
- The identification and implementation of significant efficiencies in regulatory processes or procedures.

## Notification:

Winners and all other nominees will be notified in early May and the winner will be presented the award at the NAGRA Annual Conference.

## Michigan Gaming Updates

### Former Kearsley teacher accused of pocketing cash meant to help students

FLINT, MI – A former Kearsley High School teacher and coach faces charges that he took thousands of dollars in charitable contributions meant to help students for his own use.

Timothy Phipps, 49, of Flint, was arraigned Nov. 13 in District Judge Jennifer Manley's courtroom on the following counts:

- One count of Embezzlement of \$1,000 or more but less than \$20,000.
- Two counts of gambling-charitable gaming-disposition of proceeds for devoting a portion of the net proceeds of a millionaire party for an unlawful purpose by using, taking or converting a portion of the proceeds for personal use

"Phipps chaired 49 millionaire party events or paid a family member or family friend to act as chairman between 2009 and 2014," reads a statement from the Michigan Gaming Control Board. >>[Read more.](#)

### Daily fantasy sports sites under review in Michigan

"I don't know how it's not considered gambling. It's easy to get addicted to," said Cobus, 27, of Sterling Heights. "Money can go as fast as if you're sitting down at a casino."

The rapid rise of daily fantasy sports websites such as DraftKings.com and FanDuel.com, offering large cash prizes to players who pick professional athletes who perform the best in games, has caught the eye of gambling regulators in Michigan and across the country.

Officials at the Michigan Gaming Control Board are studying whether the websites violate state laws that prohibit gambling outside of licensed casinos, horse tracks and charity gaming events

"Any gambling not specifically authorized is an issue," said Richard Kalm, executive director of the gaming control board. >>[Read more.](#)

And they have parents speaking out.
