• Trade affiliates are not authorized to vote or attend closed meetings of NAGRA.
• Trade affiliates who withdraw membership shall not be eligible to rejoin as a trade affiliate until July 1 of the second year after than in which it presents notice of its withdrawal.
• Contributions or gifts to NAGRA are not tax deductible as charitable contributions. However, they may be tax deductible as ordinary and necessary business expenses.
