## 2018 NAPABA Convention CLE Help Desk Frequently Asked Questions

### **Q. How many credits can I receive for attending CLE sessions during Convention?**

A. *This program offers a maximum of 525 minutes of CLE including up to 150 minutes of Ethics credit and 300 minutes of Elimination of Bias credit in some jurisdictions. Refer to the CLE credit breakdown sheet for specific information for your jurisdiction.*

### **Q: Do any sessions qualify for Ethics Credit?**

A: *Sessions 104, 201, and 401 qualify for Ethics credit in many jurisdictions. Refer to the CLE chart to see if your state approved this session for Ethics credit.*

### **Q: Do any sessions qualify for Elimination of Bias Credit?**

A: *Sessions 104, 201, 305, 306, 401, and 402 qualify for Bias credit in some jurisdictions. Refer to the CLE chart for more details.*

### **Q: Do any sessions NOT qualify for CLE credit?**

A: *CLE is not available for the following sessions: 102, 204, 307.*

### **Q. My jurisdiction is listed as credit through reciprocity, what does that mean?**

A. *Many jurisdictions accept credit for courses approved in other jurisdictions through their approved reciprocity policy. If NAPABA is seeking credit through reciprocity, we will use an approved jurisdiction with the maximum credits for which we are approved for. Your certificate of attendance will provide the necessary information.*

### **Q. I lost my badge, what should I do?**

A. *Go to the onsite registration desk.*

### **Q. I missed the scanning period, will I still receive credit?**

A. *Please go to the CLE help desk. Your attendance will be recorded, and you will receive credit for the time spent at the session.*

### **Q. I am a speaker, how will I receive my CLE credit?**

A. *A volunteer should scan your badge before the session starts. If your badge was not scanned, please visit the CLE help desk. After the meeting, please contact [cle@napaba.org](mailto:cle@napaba.org) to receive your additional credit.*

### **Q. I am a law student, do I need CLE credit?**

A. *Law students are welcome to attend CLE sessions, but are not eligible for CLE credit.*

### **Q. What are the CLE requirements for my jurisdiction?**

A. *You should consult your jurisdiction's website for information regarding requirements.*

**Q. How will I receive my certificate of attendance?**

A. *All Convention attendees will receive an email following the Convention with a link to our online CLE system. This email will contain instructions on how to confirm your participation and print your CLE certificate of attendance.*

**Q. When can I expect to receive the email with instructions to download my certificate of attendance?**

A. *Within 2 weeks following the Convention. If your state requires sponsors to report attorneys' attendance, we will report your attendance by December 7, 2018.*

**Q. What if my state is pending when I use the online CLE system?**

A. *Follow the instructions in order to confirm your participation using NAPABA's online CLE system. NAPABA will contact you immediately upon receiving accreditation from your jurisdiction, so you can print out a correct certificate of attendance.*
