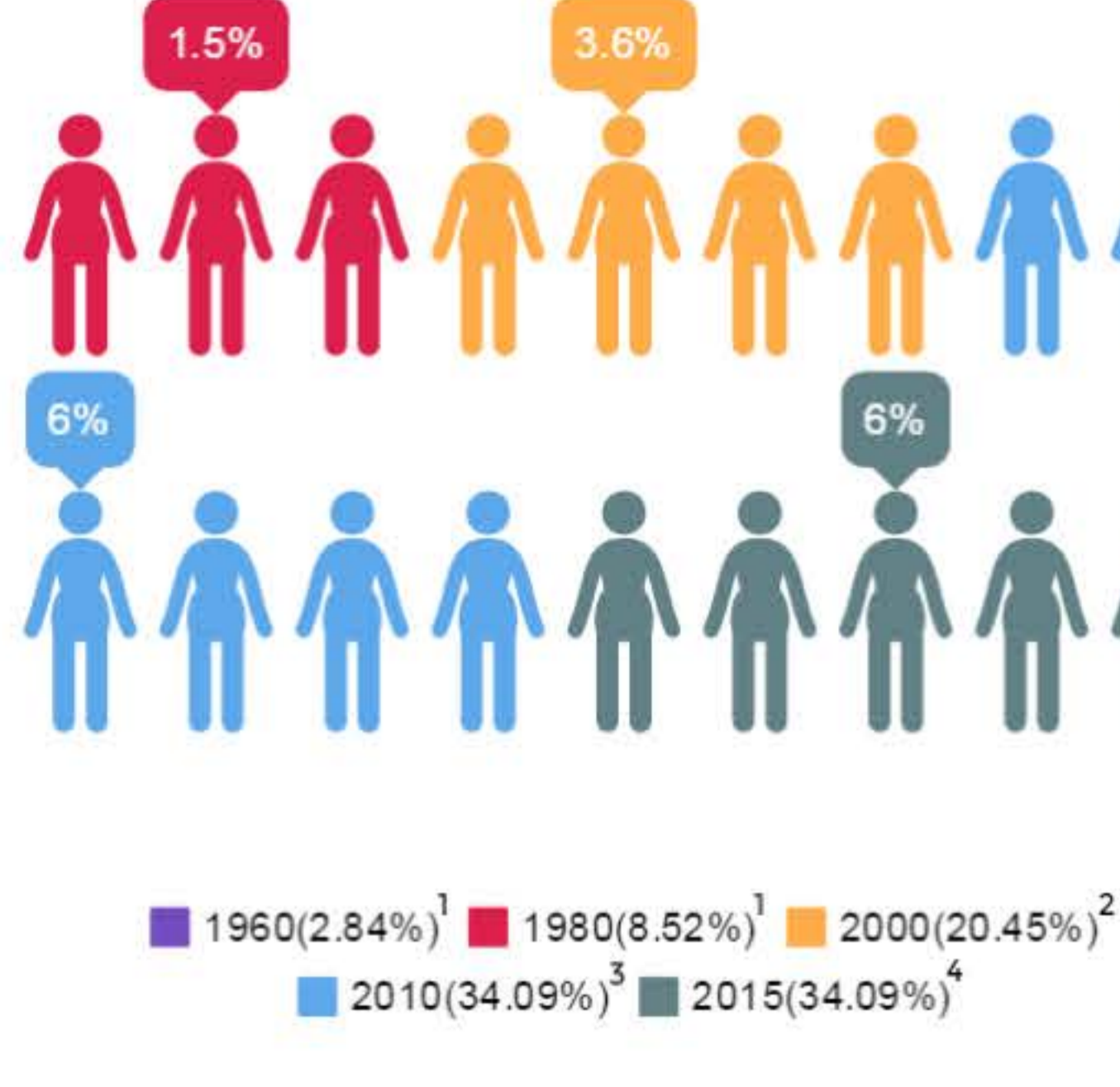


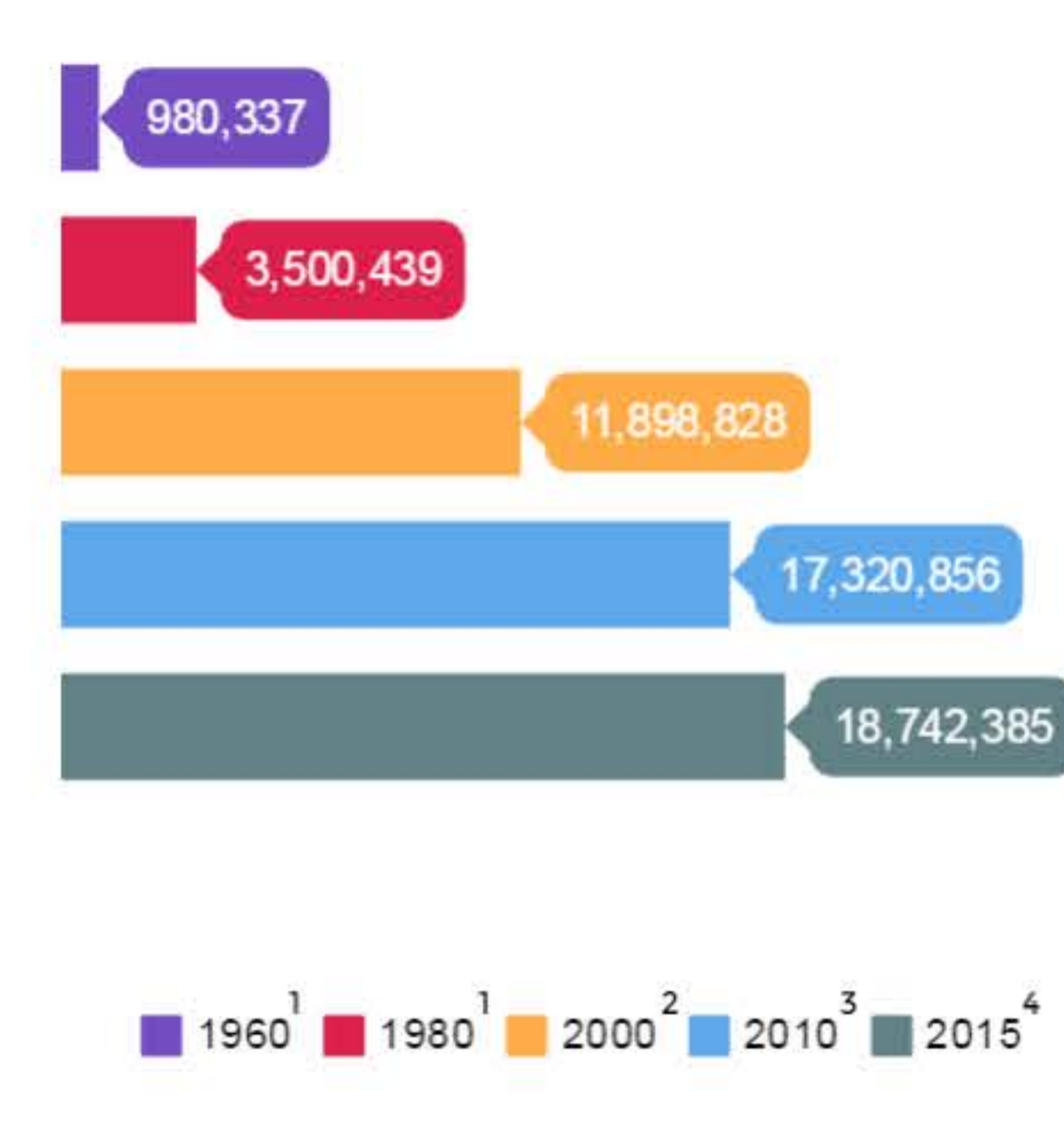

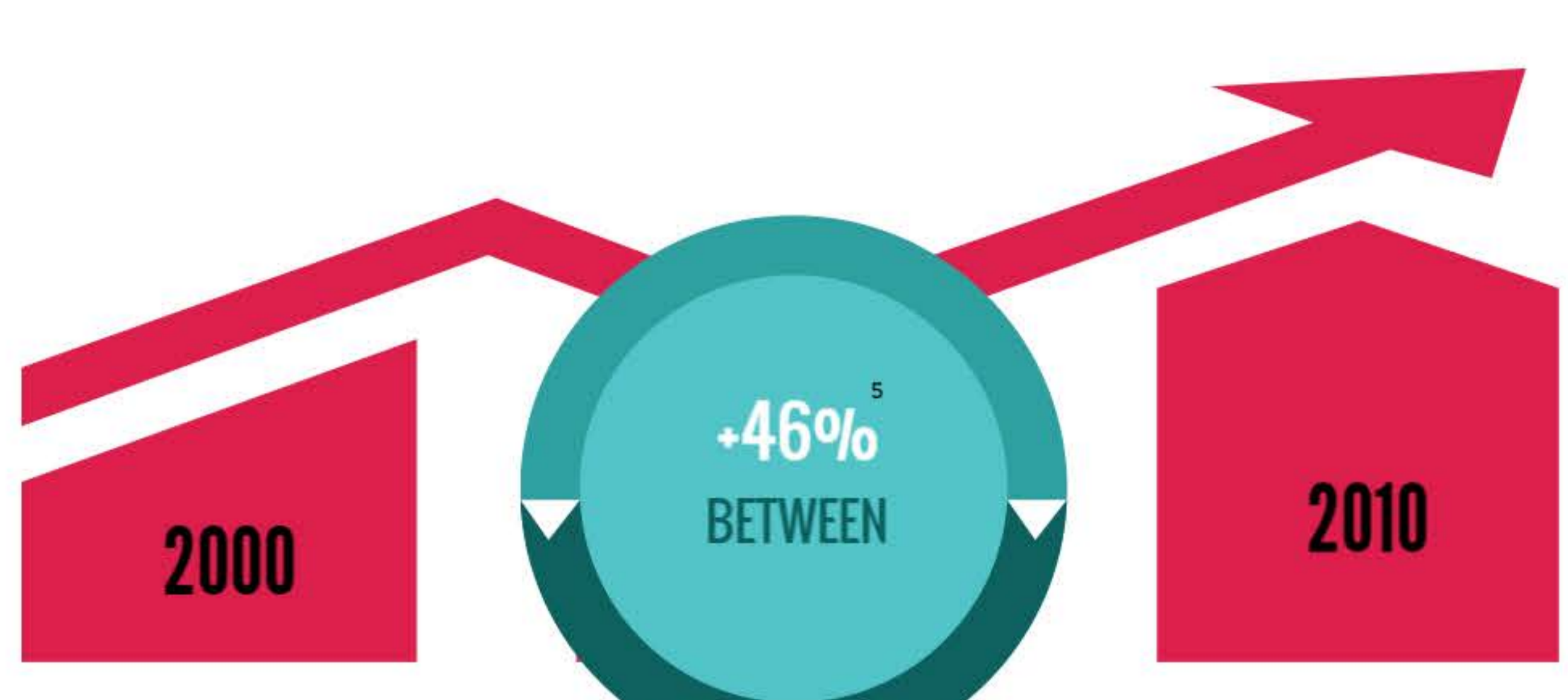
### ASIAN PACIFIC AMERICAN POPULATION IN THE U.S.



### # OF ASIAN PACIFIC AMERICANS IN THE UNITED STATES

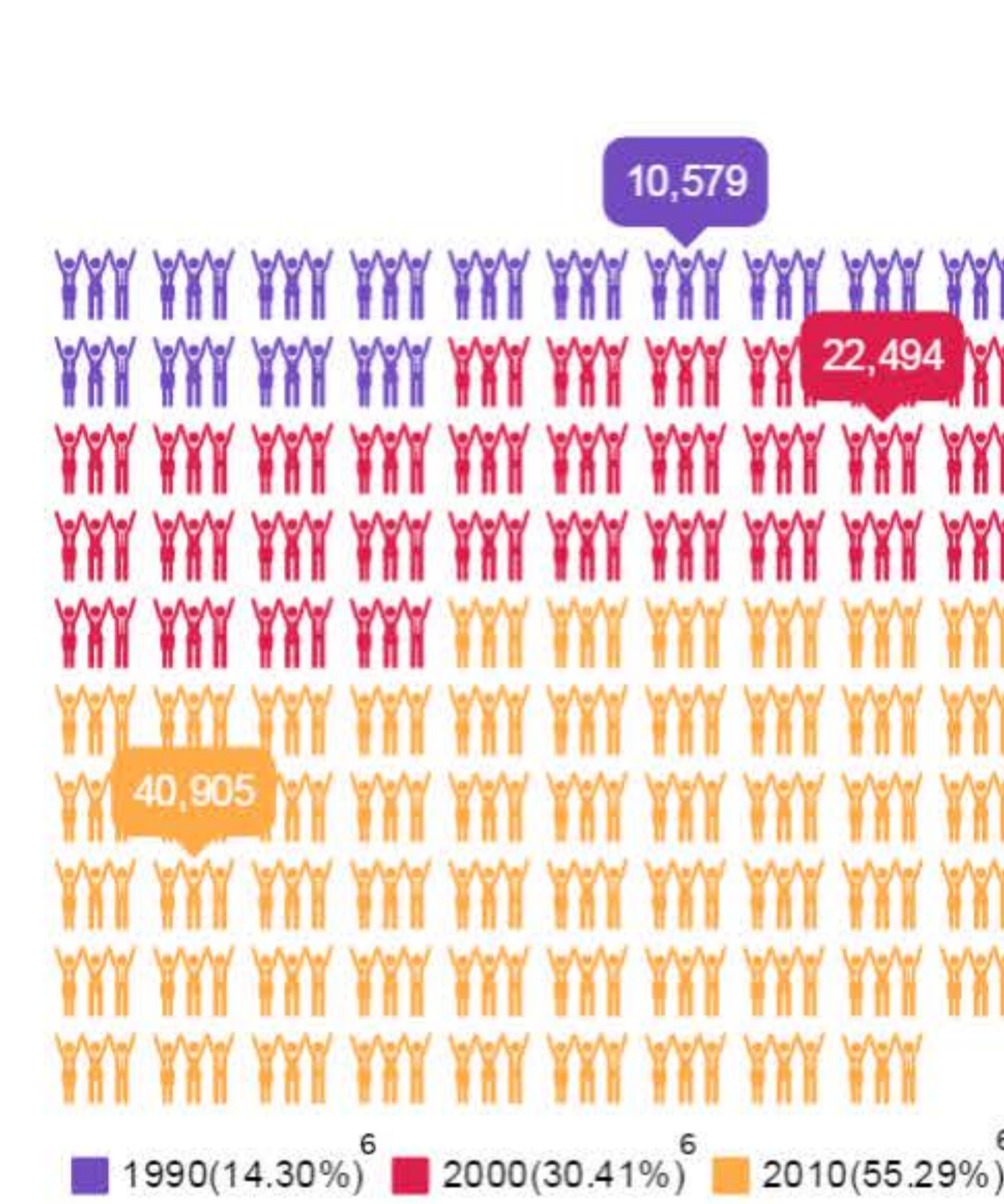


### ASIAN AMERICAN POPULATION GROWTH

### % OF ASIAN PACIFIC AMERICAN LAWYERS IN TOTAL LAWYER POPULATION

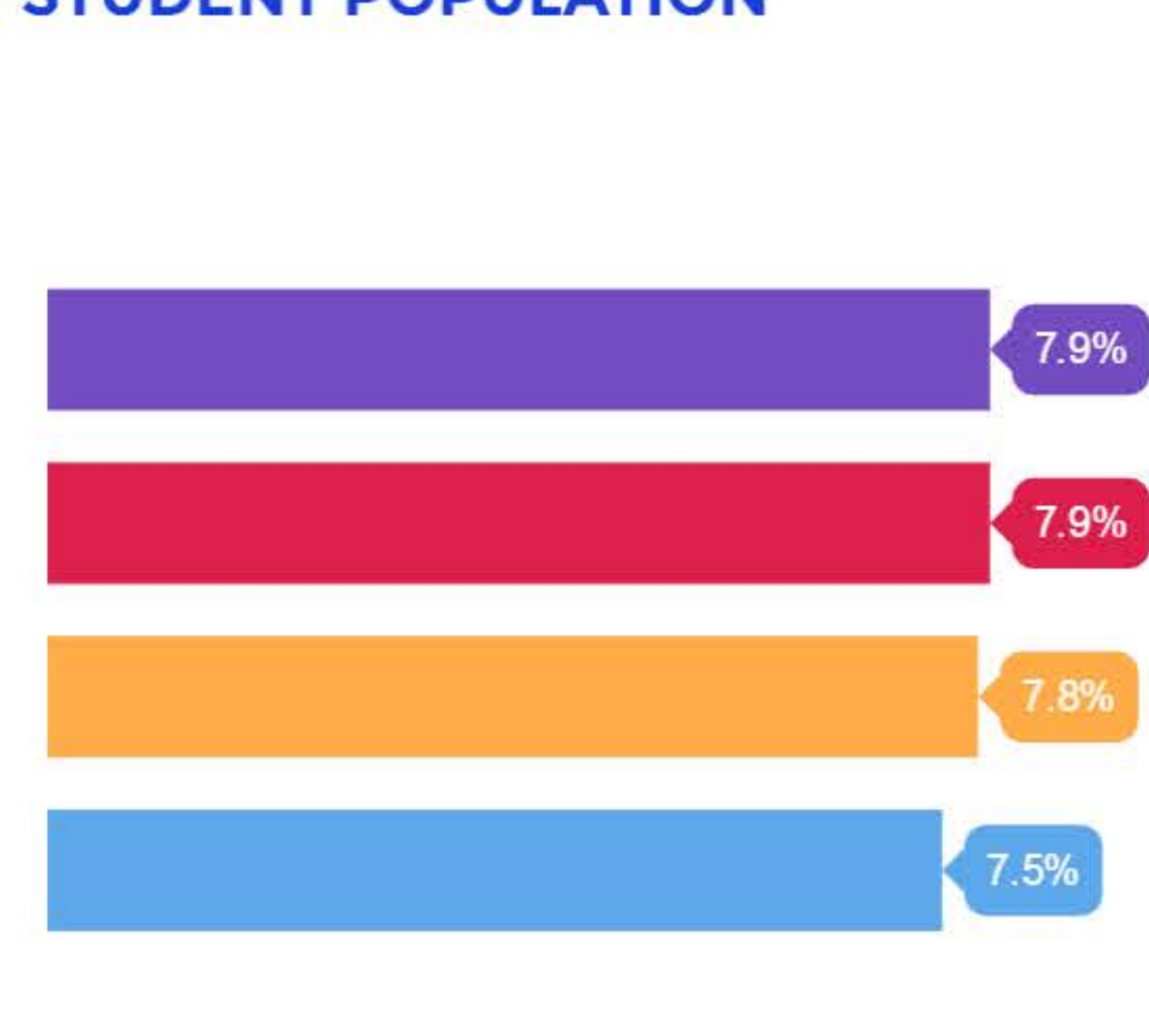

### # OF ASIAN PACIFIC AMERICAN LAW STUDENTS

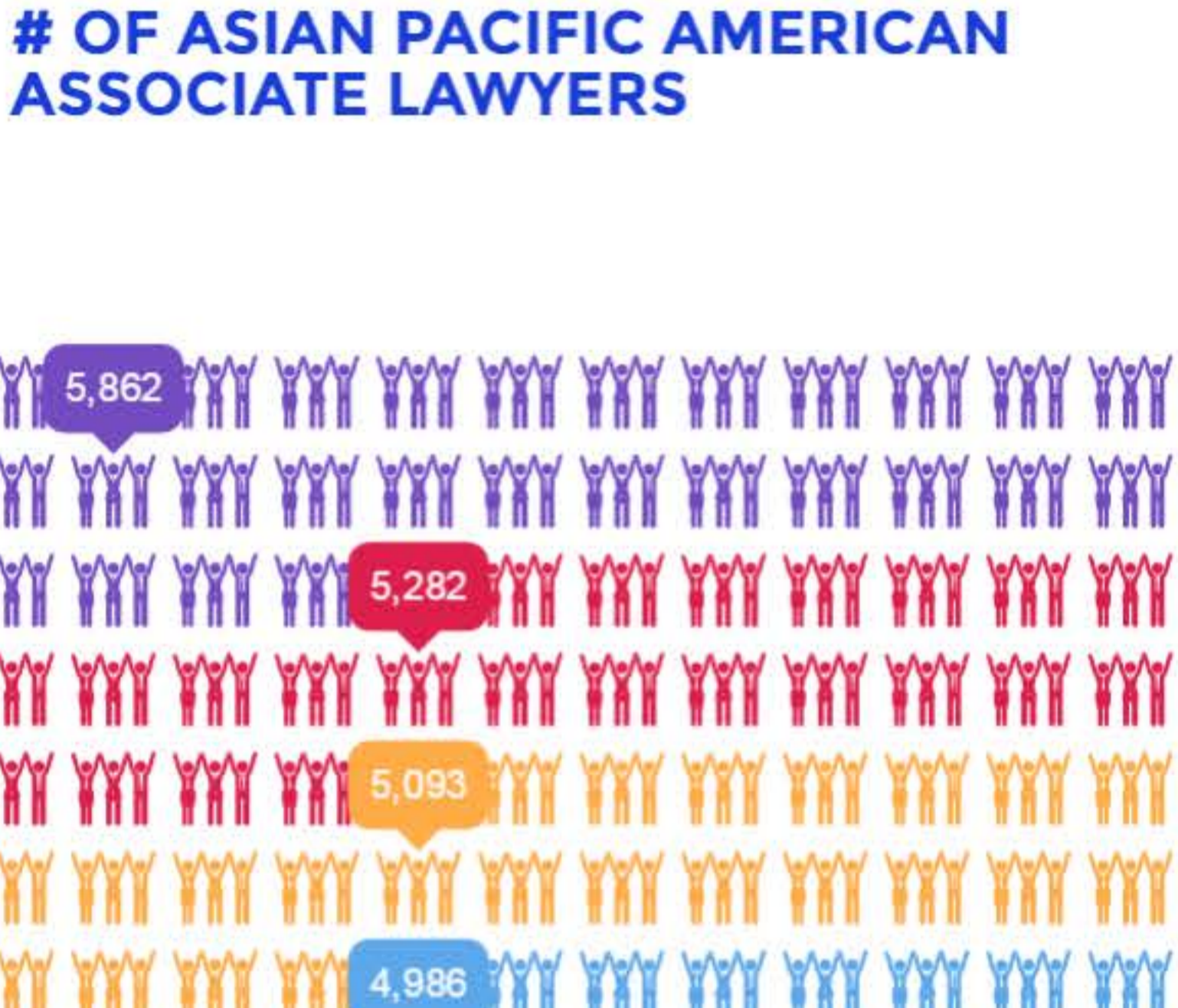


### % OF ASIAN PACIFIC AMERICAN LAW STUDENTS IN TOTAL LAW STUDENT POPULATION

### % OF ASIAN PACIFIC AMERICAN PARTNER LAWYERS IN TOTAL PARTNER LAWYER POPULATION



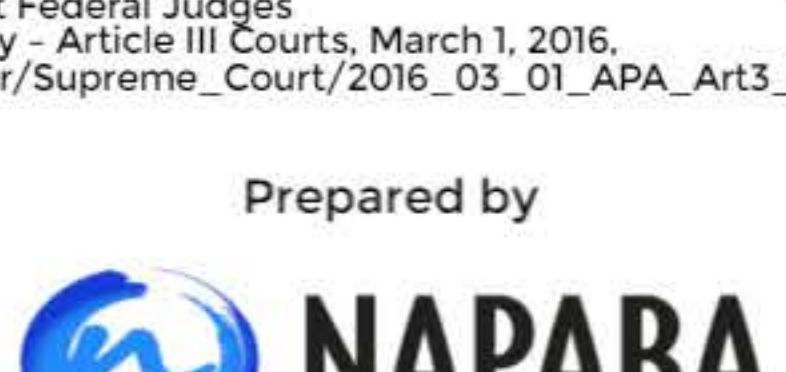
