

Social Work Loan Program Application

- Social Work majors who are experiencing a financial crisis will be able to apply for short term, no interest loans for up to \$300.00 through the NASW-NE Social Work Loan Committee.
- This loan is available to declared BSW and MSW Social Work majors who are also members of NASW-NE for 6 months or longer. (if less than 6 months, a waiver may be requested)
- Student borrowers have 90 days from the receipt of the funds to repay the loan in full.
- Students may borrow up to two times per year. A student may not borrow again until their previous loan has been paid in full.
- Applications are available on line at www.naswne.org.
- A unanimous decision by the Social Work Loan Committee will determine eligibility. Eligibility for the loan will be determined within five business days.
- Students who are approved for a loan will be required to sign a repayment agreement prior to receiving the loan. After signing the repayment agreement, students will receive a check immediately.
- New borrowers and equity between schools will be considered in the application process.
- Loan repayment must be in the form of a cashier's check, money order, or a personal check within 90 days of receiving the loan. Checks may be made out to: NASW-NE Social Work Loan Program.
- If the borrower is unable to pay within 90 days, written notice must be given to the Social Work Loan Program. Extenuating circumstances will be considered.
- The Social Work Loan Committee reserves the right to request a meeting with frequent or delinquent borrowers to discuss financial counseling if it appears there is an on-going financial concern.
- When and if it becomes possible, borrowers are asked to consider a donation to ensure the continuation of the program.
