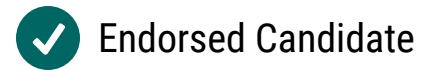

## General Election – November 3, 2020

NASW's Political Action for Candidate Election (PACE) Committee is registered as a political action committee at the federal and state levels. PACE is a non-partisan organization that makes its decisions based on a combination of voting records, candidate questionnaires and/or interviews, and other factors. NASW-PA PACE is run by a volunteer leadership team comprised of NASW members from across the Commonwealth. First consideration was given to candidates who completed the NASW-PA PACE Endorsement Questionnaire, which provided an assessment of candidate views on NASW-PA priority issues such as mental health parity, social justice, health care, funding to social services, telehealth, and workforce issues in the social work profession. Consideration for incumbents included past support of NASW-PA legislative initiatives, and past recipients of the NASW-PA Legislator of the Year.
