Dear NASW-NYC family,

## **Remarks from Board President Benjamin (Ben) Sher, LMSW, MA**

Dear NASW Community:

Sunday, July 1<sup>st</sup>, 2018 marked my first official day as the President of the New York City Chapter of the National Association of Social Workers. With the June 30, 2018, “Families Stand Together” Rally at Cadman Plaza in Brooklyn, I had the honor of being with Candida Brooks-Harrison, as she completed her presidency. It was a fitting coda to her great work as President to be able to speak out together about the inhumane policies of the Trump Administration towards immigrants. Serving in the role as President-Elect for the last year with Candida has taught me much about my roles and responsibilities as President, and it was wonderful to have another chance to learn from her actions. I thank her for all of her guidance and wisdom.

Over the last year, I have reflected often on what type of President I want to be. I know that I want to build on the legacies of Martha Sullivan, Sandy Bernabei, and Candida. - How will I measure the direct impact NASW-NYC is having on issues of social justice, economic disparities, and racism?

These are not easy questions to answer, nor should they be. As social workers we experience on a daily basis challenges to the values and ethics we hold dear. NASW must be a place of support for our field as well as a stage of activism. Paraphrasing the great words of Sandy Bernabei, NASW must be the place to continue to have each other’s back. It is my goal as President to support this mission. I truly look forward to being the type of leader who lives by this motto.



## Living While Black Townhall

On September 6, 2018, NASW-NYC Executive Director, Dr. Claire Green-Forde participated on the panel of the “Living while Black Townhall” hosted by Senator Jesse Hamilton. The Townhall addressed the emerging issues of 911 being called on black people for doing normal daily routines such as eating lunch on college campus, holding a barbeque, and waiting for friends at Starbucks. The discussion also focused on the Senator’s proposed 911 Anti-Discrimination, Anti-Harassment legislation, which would make calling 911 on innocent people of color a hate crime.



## Press Conference with Assemblywoman Deborah Glick

On July 17, 2018 NASW- NYC participated in the press conference with Assemblywoman Deborah Glick, urging the New York State Senate to return to Albany and pass the Speed Camera bill and Reproductive Health Care Act.


“As a profession that supports self-determination and the worth and dignity of the person, the passage of the Reproductive Health Act (A.1748/S.2796) and Speed Camera Bill

(A.7798C/S.6046C) would support women, children and families; key constituents served by city social workers,” said Ben Sher, President, NASW-NYC Board of Directors. “The New York Senate must return to Albany to support the fundamental human right to choose within the Reproductive Health Act and inherent need to keep New York’s children safe through maintaining and expanding access to speed cameras in city school zones. As social workers, we are pleased that we have active and dedicated leaders like Assemblymember Glick ready to stand up and fight for family rights.”

## **“50 Years of Progress: Challenges and Interventions for the Future” was addressed at the 50<sup>th</sup> Annual NASW-NYC Addictions Institute Conference**

The NASW-NYC Addictions Committee held its 50<sup>th</sup> Annual Institute on June 13, 2018. The event, which took place at Fordham University, attracted over 400 social workers, CASACs, and LMFTs. For the special 50<sup>th</sup> anniversary year, the conference participants were treated to a range of event offerings, including a diverse range of workshop and exhibitor booths, a digital slideshow, and a printed timeline of the past 50 years of the Addictions Institute, as well as community support meetings (Alcoholics Anonymous, Narcotics Anonymous, and SMART Recovery), and a Naloxone training hosted by NASW-NYC’s long-time supporter, Samaritan Village.



Keynote Speaker: Dr. Peter Steinglass

The 2018 keynote speaker was Dr. Peter Steinglass, the President Emeritus of Ackerman Institute for the Family and Clinical Professor of Psychiatry at Weill Cornell University Medical College. Dr. Steinglass focused on substance use disorders with an emphasis on the family system using his clinician-researcher lens, setting the tone for the day.

Attendees participated in a record number of breakout workshops covering the intersection of behavioral health and a gamut of focused areas from adverse childhood trauma to elder substance use. Overall, the day was full of impactful learning, collaboration, and networking.

NASW-NYC would like to extend our appreciation to all conference attendees for supporting Chapter programming as well as to the wonderful presenters and exhibitors who shared their expertise and resources.


