## NFH Photo Contest: Rules, Terms and Conditions

NFH invites cabin owners to enter its **2018 Cabin Life Photo Contest**. You must read the following rules, terms and legal conditions before submitting any photos. NFH's **2018 Cabin Life Photo Contest** (the "Contest") is open to ALL photographers at least 18 years of age, except employees of NFH, NFH Directors and the immediate families of such employees and Directors. The contest is open to all participants regardless of residence or citizenship, so long as the laws of their jurisdiction allow participation.

**WHAT TO ENTER:** We are looking for images that depict cabin life, featuring your family or friends enjoying your cabin. Ideally, the photo shows your cabin, but we accept pictures of cabin activities without the cabin featured. Photo captions must accompany all submissions, and should include the subject of the image, the location the image was taken, and the name of the photographer(s). Also your National Forest and state should be noted.

**SPONSOR:** Sponsor is NFH, PO Box 336, Talent, OR, USA ("Sponsor" or NFH)

**TERM:** The 2018 NFH Cabin Life Photo Contest (the "Contest") begins **March 20, 2018 and ends April 23, 2018**. ALL ENTRIES MUST BE RECEIVED BY APRIL 20, 2018 by 23:59 PST. Information on how to enter and prizes form part of these official rules ("Official Rules"). By submitting an entry, each entrant agrees to the Official Rules and warrants that his or her entry complies with all requirements set out in the Official Rules. This is a skill-based contest and chance plays no part in the determination of winners. Winners will be contacted on or before April 28, 2018 and all winners will be announced during our 2018 NFH Conference in Sacramento on April 28, 2018. Photos will be also be posted on our NFH website with the name of the forest and state in which the cabin is located.

**HOW TO ENTER:** Each entry consists of an entry form and a single image. To enter, email NFH at [info@nationalforesthowners.org](mailto:info@nationalforesthowners.org), include the required information - your name, address, telephone number, e-mail address, National Forest and state where your cabin is located and photo caption - and submit along with your photograph in accordance with the instructions that follow.

There is limit of 3 entries per person. Each entry must comply with the following requirements (the "Photograph Requirements"):

- HDR photographs and minor burning, dodging and/or color correction is acceptable, as is cropping. Stitched panoramas are NOT acceptable. Any changes to the original Photograph not itemized here are unacceptable and will render the photograph ineligible for a prize.

- Digital files must be high resolution, 300ppi, file size 3MB or larger (at close to actual size) and must be in .jpg format.
- The photograph, in its entirety, must be a single work of original material taken by the Contest entrant. By entering the Contest, entrant represents, acknowledges and warrants that the submitted photograph is an original work created solely by the entrant, that the photograph does not infringe on the copyrights, trademarks, moral rights, rights of privacy/publicity or intellectual property rights of any person or entity, and that no other party has any right, title, claim or interest in the photograph.
- The photograph must not, in the sole and unfettered discretion of the Sponsor, contain obscene, provocative, defamatory, or otherwise objectionable or inappropriate content.

Images will be judged on originality, technical excellence, composition, overall impact and artistic merit. The judges are a panel of NFH staff and board members who will select finalists and winners. All entries must be submitted and received by April 20, 2018 at 23:59:00 PST. Proof of submission is not proof of receipt. Entries must be made by the authorized account holder of the e-mail address submitted at the time of entry. NFH shall determine winner eligibility in its sole and absolute discretion. All decisions made by the judges are final.

## **YOUR RIGHTS:**

Your photographs help NFH in its mission to protect and preserve the cabin program. Thank you for helping to further our mission through your photography.

**You will retain all rights to any photograph you submit — including ownership if applicable.** By submitting photos in the Contest, you grant NFH a royalty-free, nonexclusive right, in perpetuity, to:

- Use the photograph on the Internet in support of our mission.
- Use the photograph in NFH's non-commercial communications.
- Provide your photograph to other individuals and organizations for non-commercial use, NFH-related use in news stories, newsletters, reports, slide shows, displays, web pages, and the like.
- Use, in connection with the Photo Contest, your name, cabin forest and state in promotions and other publications.
- Keep the files provided, and to archive the images on CD or in other electronic forms, so that your photos can be used to support our mission and be properly credited.

As conditions of this permission, NFH shall credit all photographs with the Contest entrant's name.
