GLENN ROACH'S BIOGRAPHY



Mr. Glenn Roach, ENP brings more than **37 years of experience** in government, corporate, and entrepreneurial emergency communications settings to the NENA Board of Directors. Mr. Roach began his public safety career as a 9-1-1 supervisor for the City of Houston in January 1986. That same year he also became a member of NENA: The 9-1-1 Association. Since then, Mr. Roach has expanded his local level efforts to include state, federal, and international work in 9-1-1 and emergency communications administration, operations, technology, regulations, legislation, and consulting in both the **public and private sector** spheres.

Mr. Roach's connections and commitment to the association extend beyond membership. He has collaborated on the **NENA i3 standard since its inception**, held **ENP certification since the program's inception** in the 1990s, and participated on various working groups over the years. Furthermore, Mr. Roach has attended every annual NENA Conference & Expo since 1987 save one. His agency, board, and council experience includes serving as the Texas Commission on State Emergency Communications (CSEC) deputy director, the Massachusetts Statewide Emergency Telecommunications Board (SETB) executive director, an iCERT board member, and an APCO Commercial Advisory Council member. In 2018 as part of its 9-1-1 50th anniversary celebration, NENA named Mr. Roach **one of the 50 most instrumental people**, organizations, and companies "in the conception and development of 9-1-1 during the past fifty years."
