Subject: NFRC – PCP Bulletin 2017-03 (Action Suggested)

This bulletin announces the publication and implementation of the NFRC 700-2018, NFRC 701 Series for 2018, NFRC 702-2018, NFRC 703-2018, and NFRC 705-2018.

The Licensee's quality control system per NFRC 700-2015, and IA's existing inspection processes per the NFRC 702-2015, for the NFRC Product Certification Program remain in effect *until January 1, 2018*.

Item 1: Publication and Implementation of NFRC 700-2018

The NFRC Board has approved [NFRC 700-2018: Product Certification Program](#) document with implementation of ballots from the Fall 2017 Meeting in San Diego, CA. The implemented changes may be found in the redline version of the NFRC 700-2018 document, [which is available for review HERE](#).

Item 2: Publication and Implementation of the Full NFRC 701 Document Series for 2018

The NFRC 701 Series of Laboratory Accreditation Program documents for 2018 has been approved. Item 3: Publication and Implementation of NFRC 702-2018

The NFRC Board has approved [NFRC 702-2018: Certification Agency Program](#) document, which is published and implemented and available on the NFRC Website.

The following language is implemented on January 1, 2018, as approved by the Board:

- Plant Audits, Sections 3.2.2.3 and 4.1.2
 - Language was modified for strengthening the details of plant inspections, achieving a higher level of consistency between IAs, and to support the modifications to the NFRC 700 program for Quality Control System.

Item 4: Publication and Implementation of NFRC 703-2018

The NFRC Board has reaffirmed the [NFRC 703-2018: Research Program Manual](#), which is published and implemented and available on the NFRC Website. As a reaffirmed document there are no modifications to the program.

Item 5: Publication and Implementation of NFRC 705-2018

The NFRC Board has reaffirmed the [NFRC 705-2018: Component Modeling Approach Product Certification Program](#) document, which is published and implemented and available on the NFRC Website. As a reaffirmed document there are no modifications to the program.
