A CALL FOR PRESENTATIONS IS NOW ISSUED

The National Plasterers Council (NPC) has issued a Call for Presentations for the 31st Annual Conference, scheduled to take place February 12–14, 2020 at the Royal Sonesta Houston Galleria, Houston, TX.

The NPC is seeking manuscripts and presentations covering a range of swimming pool plastering-related subjects to ensure that delegates are offered the most innovative, timely, and relevant issues in the pool industry today. The NPC Annual Conference is an important educational event that offers a forum for cementitious pool industry professionals to exchange new ideas, innovations, processes, and technologies. The 2020 NPC Annual Conference is expected to attract more than 500 cementitious pool and spa professionals within the swimming pool community.

Based on the submission of abstracts, selected individuals will be invited to submit their paper and deliver presentations at the NPC's 31st Annual Conference in February, 2020. Presentations will be selected based on the specific criteria, including relevance, originality and non-commercial tone and content. Abstracts will be reviewed and evaluated by the Education Committee of the National Plasterers Council as they organize the program for the conference. HOW TO APPLY

Please submit your 150-word abstract on or before **August 1, 2019.**

The abstract must include sufficient detail to permit a thorough review and evaluation of the presentation's proposed content and significance. Applications and abstracts received after **August 1, 2019** may not be considered. If you need additional applications (for multiple presentations), please scan or photocopy the accompanying form, or print a copy from the NPC website at www.npconline.org.

If your abstract is selected, you will be notified of the decision by September 9, 2019 and invited to submit a presentation based on the approved abstract. Acceptance of your abstract does not guarantee acceptance of your paper. Specific guidelines for preparation of your presentation will be provided at the time of abstract acceptance, along with audio/visual guidelines for your presentation. Final presentations are due no later than January 2, 2020.

Failure to provide your presentation by this deadline may result in cancellation of the presentation.

CRITERIA FOR PRESENTATION SELECTION

The NPC Education Committee will invite presentations based on abstracts received, using the following criteria:

- Relevance
- Accuracy
- Practicality
- Appropriate use of case histories, user experiences, and actual industry applications
- Focus
- Quality
- Completeness of abstract
- Usefulness
- Noncommercial tone and content
- Uniqueness
- Timely submission of application and abstract

Presenters are encouraged to challenge every facet of the cementitious pool industry to raise its level of expectations, quality and performance.
