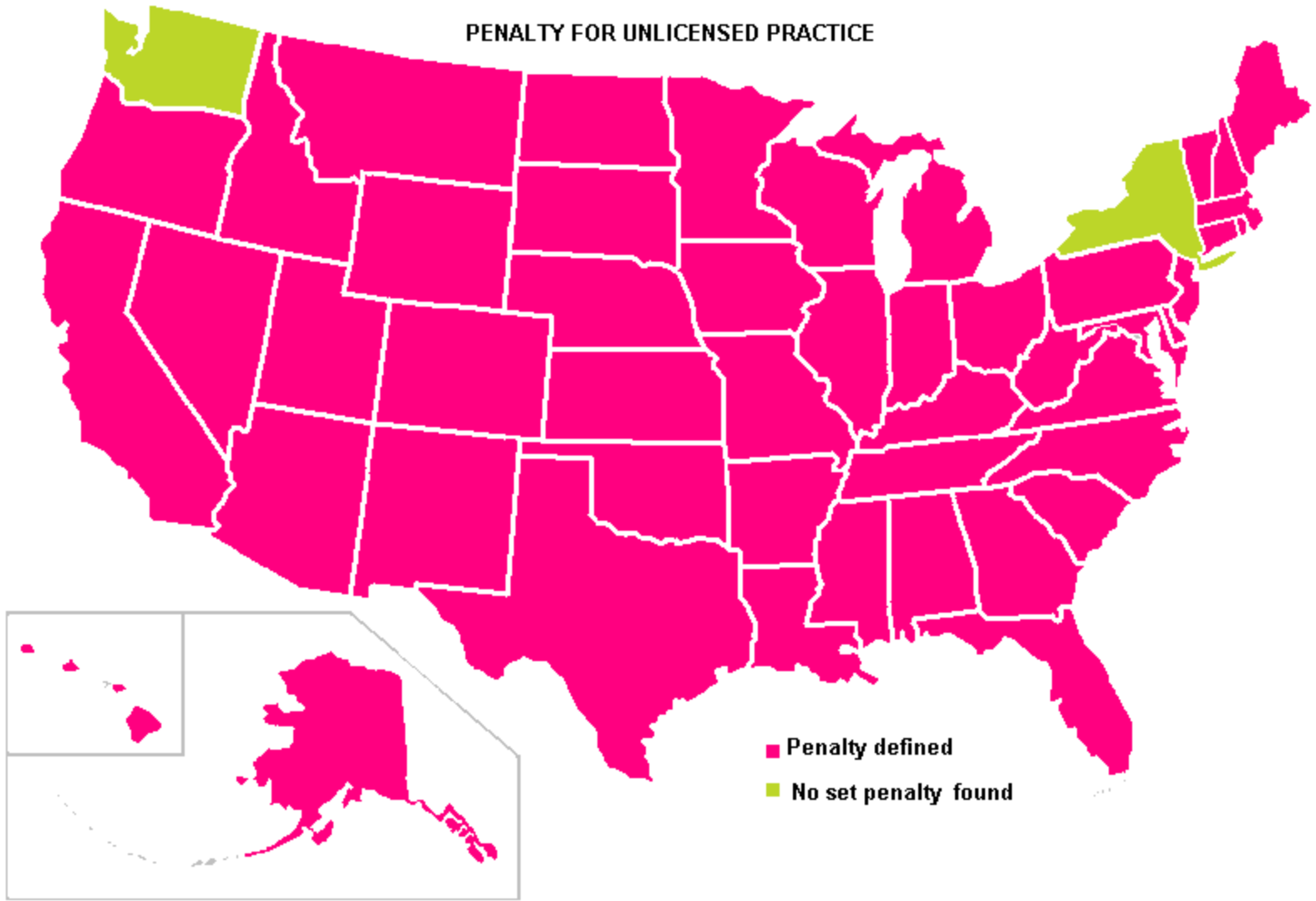

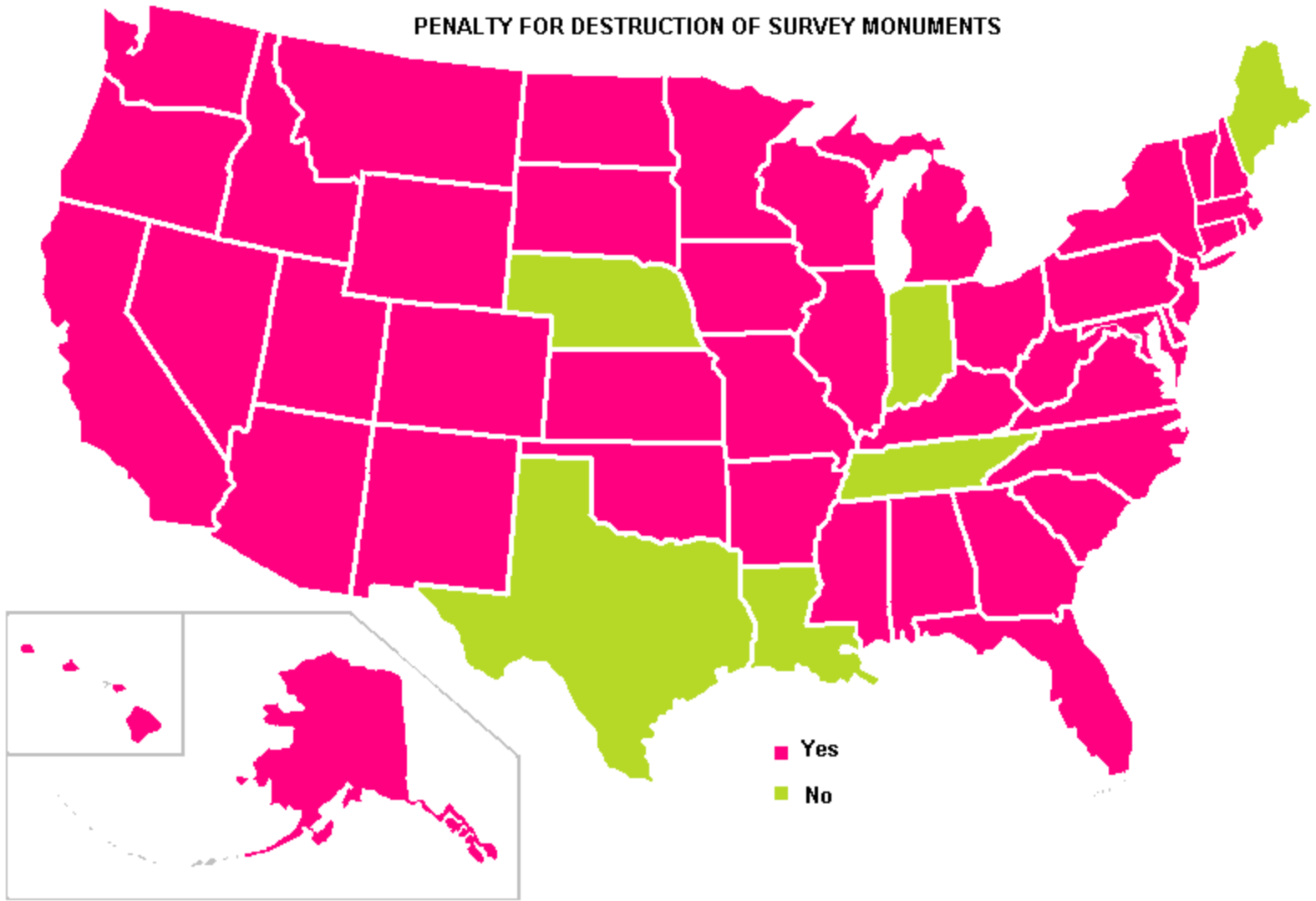
RIGHT OF ENTRY FOR SURVEYORS
