## MONDAY MORNING

January 28, 2019

#### **Tying into Historical Documentation**

NY CE: 4.0 LS/PE Adolf H. Jonietz, PLS 8:00am – 12:30pm

This course will show attendees how to take the "Past" history (documentation and archive maps) and tie them to today's environment with the aid of an aerial overview, to help recover "old" physical evidence. This will give "history" a current record and can be used in the future when the "environment" continues to move forward covering the "past".

#### **How to Write a Business Plan**

NY CE: 1.5 LS/PE

William E. Beardslee, PLS, PE, PP 8:30am – 10:00am

Whether starting a new firm or trying to control an existing one, a solid business plan is the critical framework element. The plan will define the direction of the firm and the methodology for completing an intermediate or long-term goal, as well as dealing with consumers. This introductory course will create a sufficient understanding of a business plan for the attendee to contribute to the structure of a firm.

# The Future of the State Plane Coordinate System

NY CE: 1.5 LS/PE Daniel Martin 8:30am – 10:00am

The State Plane Coordinate System (SPCS) is being redefined as part of the transition from the North American Datum of 1983 to the Terrestrial Reference Frames of 2022. The presentation discusses proposed SPCS2022 policy and procedures, including technical characteristics and requirements; default designs (created by NGS in the absence of stakeholder input); "layered" zones (a single statewide zone plus a system of sub-zones); "special purpose" zones (providing coverage for areas that straddle two or more zones); and who, what, when, and how input used for defining SPCS2022 can be provided to NGS.

### 3D Building Rights & Air Rights

NY CE: 1.5 LS/PE

Joanne Darcy Crum, PLS, Esq. 8:30am – 10:00am

This course will cover an overview of Light & Air Laws & Easements and the impact of transferred development rights. The course will also include a case law review and discussion of seminal legal cases that help define Light and Air Easements.

#### **Basic Survey Math**

NY CE: N/A Joseph V.R. Paiva, PhD, PS, PE 8:30am – 12:30pm

This course will cover some of the procedures in surveying that are solved with the basic three branches of mathematics: algebra, geometry and trigonometry. The course will provide reminders about what you may have learned such as how to solve for an unknown that appears on the right side of the equation (i.e. right of the equals sign). Examples on how to solve if that variable appears in the denominator, i.e. the lower part of a fraction to the right or left of the equals sign will be reviewed. The class will perform examples of work in surveying such as latitudes and departures, coordinates calculations and adjustments of various types, not just traverse adjustment. The emphasis is on re-learning or remembering principles you likely have been taught, and then performing such problem solving manually with only an approved calculator. Time permitting, we will cover how to analyze a problem statement, i.e. a word problem, and figure out how to write an equation that states the problem including the variable that represents the answer. \*Attendees must bring an NCEES approved calculator (see https://ncees.org/exams/ calculator/)

#### **Contract Law & Preparation**

William E. Beardslee, PLS, PE, PP 10:30am – 12:00pm

Most design professionals engulf themselves with their technological needs. They need to have an understanding of the laws applicable to their profession and the laws relating to the contracts and proposals they sign. This course describes the elements of a basic contract for professional services and discusses the pitfalls created by not following these elements while considering consumer rights and needs.



#### **Tides & Tidal Datums**

NY CE: 1.5 LS/PE J. Peter Borbas, PLS 10:30am – 12:00pm

In this program we will discover the various elements of tidal waters. We'll learn how to relate tide datums to geodetic datums and your survey project sites. These projects can be for the purpose of determining land ownership boundaries or providing transportation engineers and the maritime industry with authoritative data for commerce and safe operations.

#### **Business Law**

The course will review business entities and the requirements for establishing a surveying business. The course will also cover professional liability issues, coverage, and business succession planning.

## MONDAY AFTERNOON

#### **BIM for the Professional Land Surveyor**

NY CE: 4.0 LS/PE Greg A.M. Hale, PE 1:30pm - 6:00pm

Building Information Modeling (BIM) has become the prevalent practice for designing and constructing facilities across the world. While most believe this workflow is just another form of 3D modeling, we'll explore the reasons why it is so much more. The course will be broken down into four parts. The first section will take a look at the fundamentals of BIM and the broad range of application it can influence. The focus will be on what this means for the professional land surveyors and how this profession can become involved in the process beyond field measurement. The second part will focus on the intricacies of capturing as-built conditions of sites and buildings and how they are used for creating a building information mode (BIM). The third part will focus on the Associated General Contractors (AGC) introduction for the Level of Development (LOD) specifications to articulate the content and reliability of BIMs at various stages of the project. The US Institute of Building Documentation (USIBD) also introduced

the Level of Accuracy (LOA) documents to specify the accuracy for building documentation services. These two sets of documents work concurrently to help standardize the exceptions between parties for scanning and BIM creation. We will explain how these documents can be used in professional practice. Finally, we will look at how BIM extends far beyond 3D coordination and design. Construction teams are starting to utilize more automated methods of equipment layout and verification and facility owners are becoming more sophisticated with how they are utilizing BIMs. We will look at these workflows and identify opportunities to become part of this ecosystem.

#### **Highway Law, Part 1**

NY CE: 4.0 LS/PE Laura E. Ayers, Esq. 1:30pm — 6:00pm

An overview of New York State Highway
Law and related case law with respect to
the establishment of highways. Topics to be
addressed include: the current and former
legislative, statutory and common law schemes
to create public and private highways in New
York State with particular emphasis on Section
300 et seq. of the highway law regarding the
private condemnation of land for access to
landlock properties.



NY CE: 4.0 LS/PE Michael H. Webb, PLS 1:30pm – 6:00pm

Dendrology is the study of trees and woody plants. This course is directed toward the skill of identifying different tree species that the New York State Land Surveyor would come into contact with in the course of preparing a survey. Whether locating a specific tree or stump referred to in an old boundary description to identifying a tree at a boundary corner for a new description, tree identification is an important skill for the professional surveyor. Can't tell the difference between a red and white oak, a red or sugar maple or a white and black walnut? This is the course for you. Taxonomy will also be discussed. Knowing the Latin/Greek names of various common tree species is helpful information to pass on to Architects, particularly LandScape Architects for both new and existing development. At the end of the course, test your new-found knowledge with a self-grading test of various examples of leaves, twigs and bark.

# TECHNICIAN'S TRACK

#### What is the Technician's Track?

An education track specifically designed to address the needs of pre-licensed surveying employees. It is designed for party chiefs, field crew, rod persons, students and other surveying staff specialists who demonstrate the following:

- · commitment to the land surveying profession;
- · willing to go "above and beyond" in their current position;
- have one to five years of experience in surveying techniques or currently enrolled in a college level surveying program;
- willing to be change agents and risk takers in their company; and,
- open to examining their current thinking and the status quo.

This specialized series of classes creates a learning experience where participants explore key concepts and gain greater self-awareness of their own professional advancement strategies.

Working with other future leaders, attendees build a strong community of fellow peers, explore new roles for survey leaders, identify ways to better manage work responsibilities, and enhance their commitment and motivation as a surveying professional.

#### Is there a registration fee?

Discounted registration is offered for the Technician's sessions. You can attend the specialized Technician education track Monday through Wednesday. You may also visit the exhibition hall, featuring the largest gathering of surveying suppliers and manufacturers in the Northeast.

#### Who should attend?

Surveying field crew staff and those striving to obtain experience necessary to obtain a license. College and University students are encouraged to attend as these programs will provide a "real world perspective" on job opportunities and experience needed to become a licensed land surveyor.

# Presenting Your Project – The Do's and Don'ts for Surveyors

Preparing and giving presentations are necessary skills of any professional. Do it wrong and at best you bore your audience and sideline yourself and your agenda. Do it well and you will secure project stakeholders including members of the public, agencies and the end client. Surveyors have an esoteric, but interesting story to tell any audience. This course will cover issues specific to surveyors and will go over the basics: don't read your text, add lots of pictures, minimize text length, keep it simple and practice. We will also go over examples and discuss more advance styles and programs that can be used to explain the scope of your project.

To accomplish that in the most efficient manor, knowing the needs of each consumer group they service is crucial for the professional to provide the required services in accordance with all consumer rights concerns. This short seminar will introduce the surveyor to the full cycle of rights review, needs evaluation, and implementation within the structure of licensing and consumer protection regulation.

#### Real World Perspectives Panel: Entering the Workforce

### **Highway Law, Part 2**

Laura E. Ayers, Esq. 8:00am – 12:30pm

An overview of New York State Highway Law and related case law with respect to the regulation and discontinuance of highways. Topics to be addressed include: the width of public highways, the interest of the public in the highway and the discontinuance or abandonment of public highways with emphasis on significant recent case law updates. This seminar will also explore the interests of the adjoining landowners

adjoining landowners with respect to existing or former public highways, including but not limited to surface water diversion, access, sidewalks and gates.



#### Stonewalls: Past-Present-Future

NY CE: 4.0 LS/PE Richard C. Brooks, PLS 8:00am – 12:30pm

Agricultural stonewalls, the grandest of all boundary line monumentation, had a distinct roll in forming New York's early landscape as well as its boundary location case law. This presentation will acquaint the attendee with geological and soil processes for the necessary annual harvest of stone out of the fields. The human interaction with these stones will be explored, looking at the walls placement, their juxtaposition and functions. Being able to identify the features of different types of walls will enable the surveyor to date them and track their evolution into a boundary fence. Tying these unique monuments to a boundary line location is not an automatic exercise. We will apply the Doctrine of Practical Location with acquiescence to a 1987 deed and follow that resulting case through the courts. The case law to be reviewed include: Kennedy v. Nimons, Appellate 3rd, (2014); Henry v Male Appellate 3rd (1999) and others. There is a modern ground swell of informed and aware citizens who are focused on the preservation of the stonewalls. The attendee will be introduced to some of the different local laws, zoning ordinances and Subdivision regulations that seek to protect these "land forms". We will discuss how to incorporate these regulation sand societal concerns into our design of subdivisions and site plans. We will review the role stone

walls played in Downey Farms v Town of Cornwall Planning Board, Appellate 3rd, (2004).



### Risk Management for Surveyors

Gary R. Kent, PLS 8:30am – 10:00am

This course will help surveyors understand the realities of liability in their practice. The program will review liability that surveyors necessarily incur as part of their practice and how they can mitigate their exposure. Source of unnecessary surveyor liability will also be explored by exposing the things that surveyors inadvertently or unwisely do that increase their liability. In all cases, we will discuss steps that surveyors can take to eliminate or at least mitigate their exposure will be outlined.

# Fundamentals of Photogrammetry for Surveyors

NY CE: 1.5 LS/PE George Southard 8:30am – 10:00am

A brief review of the fundamental aspects of the science of photogrammetry. The purpose of this session is to familiarize survey professionals with the concepts used by photogrammetrists to create map products such as topographic and planimetric maps, orthophotos, 3D cityscape map and point cloud data of these map products. This discussion will also review the use of ground control points and the application of aero-triangulation in the georeferencing of photographic and LiDAR image sets.



NY CE: 1.5 LS/PE Scott R. Reeser, PLS

8:30am - 10:00am

This session will look at various units of measure. While the focus of the session will be aimed at units encountered by a surveyor in their work, we will discuss other various units. Session discussion will include how units of measure have developed in various periods of history.

### **Survey Reports**

NY CE: 1.5 LS/PE Scott R. Reeser, PLS 10:30am – 12:00pm

This session will provide an overview of a survey report. The typical parts of a survey report will be reviewed and discussed with the attendees. Reasons for the preparation of a survey report will be discussed as well as the future value of a well written report. The attendees will be asked to share their uses and opinions of survey reports. The session is geared to be presented to experienced surveyors as a refresher on survey reports. The attendees will be encouraged to discuss the usefulness of a report of survey and share their experiences with the group.

#### UAV Accuracy Assessment for Surveying

NY CE: 1.5 LS/PE Benjamin H. Houston, PE 10:30am – 12:00pm

This course will use data from a test flight to demonstrate how to calculate geospatial data accuracy (both horizontal and vertical) for a typical drone flight. Concepts include defining "produced to" and "tested to" accuracy and calculating both Root Mean Square Error (RMSE) and 95% Confidence Interval statistics from NSSDA and ASPRS compliant reference data. The course will describe how to establish a test range and conduct accuracy testing operations and will review the primary components of error contributing to the error budget in drone mapping.

### Introduction to Research

NY CE: 1.5 LS/PE Michael H. Webb, PLS 10:30am – 12:00pm

The course begins by discussing the court structure and law libraries in the State of New York and various court decisions rank depending on the level. We will explain how court decisions are recorded and how to read and look up specific citations. How to look up court decisions by subject matter and how to use these court decisions. Finally, we will discuss a few important court cases and decisions that have an impact on the Land Surveying Profession.

It is important that they are well-versed in what easements and rights of way are, how they differ from other similar instruments like licenses, and how they are created.

# **Becoming a Certified UAS** (drone) Pilot

This presentation is a detailed review of the steps needed to qualify for an FAA Remote Pilot Certificate (sometimes referred to a as a drone pilot's license). Certification requires studying for and passing a knowledge test for remote pilots, filing an application for the Remote Pilot Certificate and getting security clearance through the TSA. The objective of this course is to help potential remote pilots negotiate through the many documents, regulations and study materials provided by the FAA.


#### **Canal Boundary Retracement**

**NY CE: 1.5 LS/PE**

For some surveyors, re-establishing the "Blue-Line" is an everyday occurrence. For many others, a canal survey may rarely or never be encountered. Spend an hour and half learning the legal authority for the creation of the canal system and how to accurately retrace these ancient boundaries today. Re-establishing the current and former boundary of the NYS canal system is typically a daunting task. Terms such as the "blue-line, red line, dashed red line, inner angle, Method A and Method B" are commonly encountered and need to be understood. Couple these unique terms with the difficulties in actually performing the field work (i.e. dense undergrowth, wetlands and the fact that many areas of the abandoned canal are filled in with 100+ years of refuse) presents today's surveyors with severe challenges. The objective of this course is to educate the attendee on legal aspects and what constitutes original evidence (i.e. "Blue Line" bolts, Barge Canal baseline monumentation etc.). These points were typically marked with unique and easily identifiable markers once you know what to look for.





# Errors Analysis with Modern Survey Technology

How does (or does not) the automatic tilt axis error correction work in a total station? What is the impact if it doesn't work? And how do you check it? Just like surveying instruments from the past that were purely mechanical and optical, modern technology (including GNSS) has a new crop of error sources and types to name, understand and account for. In this course, we will quickly review things like the nature and types of error and how best to account for them in survey planning, execution, analysis and information reporting. This course helps surveyors to learn or re-learn errors analysis that reflects modern technology.

# FAA Regulations for UAS (drone) Operations

#### **Subsurface Utility Records**

Architects and engineers are beginning to understand the value of obtaining accurate and comprehensive subsurface utility data during the design cycle of a project. As a result, the requirement for professional land surveyors to accurately depict the location of subsurface utility infrastructure has been steadily increasing over the previous 10 years.



One objective of this course is to provide resources for land surveyors to obtain utility mapping to enable a more thorough depiction of existing subsurface utilities at QL-C, and be able to qualify the accuracy of the utilities being depicted. This course will present a typical workflow of designating subsurface utilities at QL-C and QL-B (research, reconnaissance, surveying, and mapping) that surveyors can apply to their own practices. The American Society of Civil Engineers (ASCE) is developing a standard for recording and exchanging utility data that could offer opportunities for land surveyors to become the source for geospatially recording the location of newly installed utility infrastructure. A general discussion of future opportunities will be provided.

# FEMA Elevation Certificate, the NFIP and Floodplain Management Perspective

The National Flood Insurance Program (NFIP) was scheduled for reauthorization in September 2017 and there have been some short-term extensions as bills are proposed to continue to reform the program. This class will provide a summary of the current state of the NFIP and how it will influence the Surveying industry. Meanwhile. demand for elevation certificates has never been higher due to driving forces such as Biggert-Waters and the Homeowners Flood Insurance Affordability Acts that are reforming the current NFIP. This course will provide an in-depth look into how the New Elevation Certificate (FEMA form 086-0-33) is utilized by the insurance industry to rate a property's flood risk for NFIP Flood Insurance. In addition, it will explain how a local municipality uses the form to enforce their Floodplain Management Ordinance and check floodplain compliance. At the end of the course, participants will have a better understanding on how the elevation certificate should be completed, correctly, and more accurately, which will improve their residents flood insurance premiums and ensure a flood resilient structure is built. Case studies will be used to illustrate what flood loss preventive solutions are available and how to identify possible solutions using the elevation certificate that can dramatically lower an owner's NFIP premium. FEMA's Technical Bulletin 1 on Flood Opening Compliance will be reviewed along with International Code Council Construction Code and ASCE 24-14 standards.





- Recipients do not have to be licensed land surveyors, but must have served the association and the profession continuously over an extended period of time.

#### 2. Surveyor of the Year Award:

**Goal:** The NYSAPLS Surveyor of the Year award was created in 2007. It recognizes one professional land surveyor who has best supported and promoted the land surveying profession.

- Must be a licensed land surveyor.
- Service given to the surveying profession and/or the public that stands as a model of professionalism, dedication and commitment of moral conduct by a professional land surveyor.
- Demonstrated ability to enhance the land surveying profession by mentoring new surveyors, working with those in the profession who are pursuing a land surveying career, and/or emphasizing continuing education to upgrade the profession.

- Major involvement in the completion of a short term project or task that resulted in a positive asset to the association and/or profession, or to the public perception thereof.
- The committee has the right to review candidate's records of current or pending disciplinary actions.

#### 3. NYSAPLS Associate of the Year Award:

**Goal:** NYSAPLS created this award to recognize and honor an associate member who has made significant contributions to the profession, their employer and/or the public. The NYSAPLS Associate of the Year award is given to an outstanding leader who demonstrates a deep commitment to professionalism and career advancement in the field of land surveying.

- Nominee must be an active Associate or Student member of NYSAPLS and be nominated by a NYSAPLS member or committee.
- The award is open to NYSAPLS student members currently enrolled in a land surveying curriculum, employed field crew, surveying office staff and employees of an educational institution.

#### 4. Lifetime Achievement Award:

**Goal:** Awarded to an individual whose achievements in his or her career contributed to the advancement and recognition of the land surveying profession.

- Candidates are not required to hold an active registration, but must be licensed.
