Classes of Membership

<i>Class</i>	<i>Description</i>
Affiliate Member	A PLS not registered in NY, or register in NY, but who does not, nor does his/her firm, practice in NY.
Associate Member	Any person who is sponsored and approved by a local or regional association.
Corresponding Member	Non-licensed or retired surveyors, residing outside NY, interested in receiving regular mailings of the Empire State Surveyor and other pertinent correspondence authorized by the Board of Directors.
Intern Member	One who has completed the requirements of the New York State Department of Education for title of Intern Surveyor.
Out of State Regular Member	A land surveyor licensed in NY, who, is a member of his/her home state association, and whose home state association offers a reciprocal arrangement to NYSAPLS members.
Regular Member	Registered land surveyor in NY who is a member in good standing in a local or regional association which has approved this Constitution and By-Laws and whose affiliation has been accepted by the NYSAPLS.
Regular Member (At Large)	Registered land surveyor in NY, who, for extraordinary reasons, would find active participation in the regional organization a significant hardship.
Student Member	A college or postgraduate student whose interest in land surveying is exemplified by active participation in a regional assoc.
Sustaining Member	A firm or individual who by his/her interest in the land surveying profession has demonstrated support for the purposes and objectives of the Association.
