

VTL 1192 Discovery Checklist

This is a general checklist for the items you should be receiving in discovery for any VTL 1192 case, or where allegations of intoxicated or impaired driving are elements of another charge. Of course, every case is unique, and not every case will result in the creation of each of the documents and audio/visual materials listed here. On the other hand, this list is not exhaustive and some cases may have documents not listed here.

As a general principle, **CPL § 245.20** is the controlling statute, with 245.20(1)(f), (j), (s) and 245.20(2) being of particular interest.
