ONTARIO COUNTY PUBLIC DEFENDER'S OFFICE

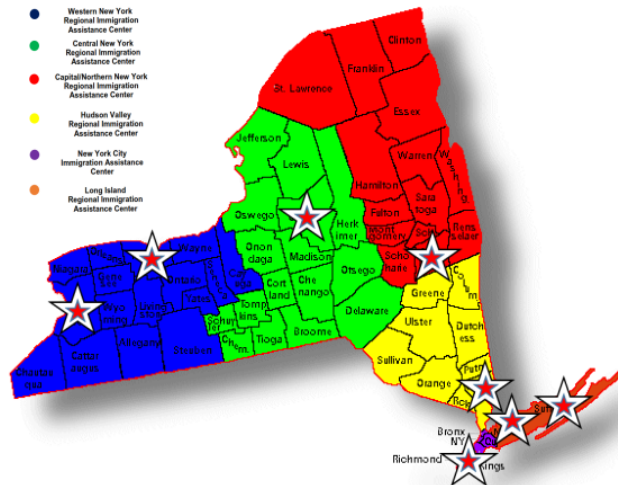

We also have a Family Court representation program, wherein we offer holistic advocacy to clients who also have matters pending in Family Court. The Public Defender's Office protects the community's interest in the administration of justice by providing zealous representation for our clients and by advocating for alternatives to incarceration. We represent individuals with substance abuse disorders and mental health issues through social work services and treatment referrals. The office advocates for participants in the Finger Lakes Treatment Courts. We also represent clients accused of violating probation and parole. Our team handles clients' legal matters competently and diligently in accordance with the highest ethical standards of the profession.

WHY WE EXIST

Changes to immigration laws have dramatically raised the stakes of a noncitizen's criminal conviction. Providing accurate legal advice for noncitizens accused of crimes has never been more important. Deportation is an integral part — indeed, sometimes the most important part — of the penalty that may be imposed on noncitizen defendants who plead guilty to specified crimes. As such, the Supreme Court ruling in *Padilla v. Kentucky*, 559 U.S. 356 (2010), now requires criminal defense attorneys to advise noncitizen clients as to the potential immigration consequences of a criminal conviction before taking a plea.

OUR GOAL

To provide training, technical assistance and other legal support to attorneys in the 7th and 8th Judicial Districts of New York who provide mandated representation to noncitizens in criminal and family court proceedings so they can fully advise their noncitizen clients as to the immigration consequences of their particular case. We are also available to consult on criminal appeals and post-conviction relief for noncitizens in removal proceedings who may have immigration issues related to their pleas.

WHEN TO CALL US

Representatives of criminal defendants should contact us as soon as possible following arraignment so that we can help you determine the immigration consequences of your client's plea.

With regard to mandated Family Court representation, please contact us anytime to discuss the possible consequences of an adverse finding or potential settlement.

We offer free CLE trainings and case review meetings. Call us to schedule one in your office or to find out about already scheduled dates.

- Client's Name and Date of Birth
- Client's Country of Birth
- Client's Immigration Status
- Client's Date of Admission/Entry to U.S.
- Penal Law Section Charged
- Is there a Domestic Violence element?
- Penal Law Section in Plea Negotiation
- Prior History of Convictions
- Any Removal Proceeding pending?
- Any Family Court case pending?
