- ◆ After completing this training, individuals may be eligible to participate in a mediation apprenticeship and serve as a volunteer mediator with New York Center. Final acceptance to an apprenticeship or volunteer panel is at New York Center's discretion.
- ◆ Upon completion, participants will be eligible to participate in New York Center's advanced mediation trainings and continuing education programs.
- ◆ This training will address the role of law and lawyers in mediation and will prepare participants to mediate in both court –referred and community contexts.
- ◆ New York Center teaches and practices in the Understanding-Based approach to mediation as developed by The Center for Mediation in Law, and is the only community mediation center to offer trainings and practice opportunities in this model.
