Agent license examination

On April 21, four members – Paul Bugoni, Tom Gifford, Maureen McElligott, and Tim Provost – attended a day-long session in Albany with the DFS to review and recommend changes to the agent license exam. It was another opportunity to show our value to the DFS as experts in this area.

Lobby Day

Lobby Day was last Tuesday, May 5th. Our lobbyists, Scott Wexler and Kate Corkery lined up the meetings, provided a briefing and prepared hand-out materials. We spoke to the legislators about technical problems with bill A163/S1278; our concerns that prohibitions against sham agencies be vigorously enforced and the new regulations proposed by the DFS.

ABSTRACTERS AND AGENTS SECTION

Chair Giliotti noted changes to section 14 of the TIRSA Rate Manual, reduced re-finance rates in sections 14-a and 14-b. A question was raised about how to indicate the 15% or 30% discount on the GFE.

City of Yonkers now has an abandoned building directory and new water meters must be installed by July 1 or fines of \$250/day will accrue.

Nassau County has approved the use of ACH for the tax map verification letter fee, but authorization must be downloaded before first use.

Nassau County does not date stamp the TP-584 and the Law Committee was asked to look into it. Also, Nassau County Recording Office continues the practice of "blocking" contractors selectively.

The Section announced it will present an amendment to the By-laws on voting rights for approval at the Annual Meeting.

DFS REGULATION 208

An extended discussion of Regulation 208 was conducted, with comments from Members and non-members.

A strategy was presented by Executive Director Treuber, with the objective of preventing the adoption of regulation 208 at the end of the SAPA comment period.

A motion was made, seconded and carried to approve the strategy and for the sake of rapidly changing circumstances to empower the Officers of the Association to execute the strategy faithfully without further consultation or approval of the Executive Committee.
