

NYSVMS WEBSITE AGREEMENT AND TERMS OF USE

This Agreement describes the terms and conditions ("Terms") pursuant to which you may access and use the New York State Veterinary Medical Society and its affiliates ("NYSVMS") website including, without limitation, any resource containing the URL nysvms.org (the "NYSVMS Website") from time to time. Please read this Agreement carefully as well as the NYSVMS's Privacy Policy which is incorporated into this Agreement by reference.

Your use of the NYSVMS Website constitutes your binding acceptance of these Terms, including any modifications we may make. If you do not agree to these Terms and the Privacy Policy, you must immediately terminate use of the Website.

In consideration of NYSVMS granting you access to the NYSVMS Website, you agree as follows:

Modification of the Terms and NYSVMS Website; Disclosure of Information

NYSVMS reserves the right at its sole discretion to change, modify, add or remove portions of these Terms at any time without notice or liability, and such modification shall become effective upon posting on the NYSVMS Website.
