



## Core Determinants of Health Screening Tool, aka the “Core 5” BECHTEL, JONES & HAWKINS

*Assess clients for the following core social determinants of health (CDH). If any one or more of the following five CDHs (the “Core 5”) is a “yes” by the client, or if the client is hesitant to answer the Core 5 screening, refer the client for more in-depth assessment and assistance.*

1. Do you/your family worry about whether your food will run out and you won't be able to get more? <sup>1, 2</sup>		
2. Are you worried about losing your housing, or are you homeless? <sup>3</sup>		
3. Are you currently having issues at home with your utilities such as your heat, electric, natural gas or water? <sup>4, 5</sup>		
4. Has a lack of transportation kept you from attending medical appointments or from work, or from getting things you need for daily living? <sup>6, 7, 8</sup>		
5. Are you worried that someone may hurt you or your family? <sup>9</sup>
