Constituent Association 4 Holiday Party - Dec. 16

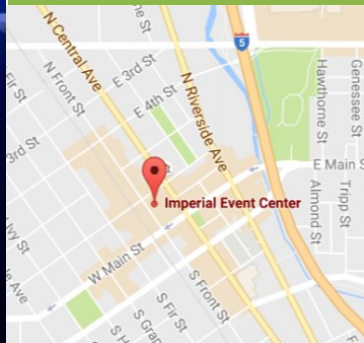


You and a guest are invited to join us for an evening delicious food, great music, and nurse recognition.
