Nominations are open for the Oregon Nurses Association (ONA) executive committee at Sacred Heart Medical Center (SHMC). This committee conducts the day to day business of the local bargaining unit. Work of this committee includes: participation in labor management committee meetings, monthly executive committee meetings, participation in unit reorganizations, coordination with the grievance committee, staffing committee and professional nursing care committee (PNCC) and, setting goals and strategic plans for the local bargaining unit. There are nine positions on the committee and all positions are open for nomination and election. This committee expands during negotiations to become the negotiating committee.

ONA members in good standing can nominate themselves or others to serve on this important committee. You may nominate more than one candidate. All nominees will be asked to provide a statement about their background and interest in serving on this leadership committee. This information will be provided to members to assist you in making your selection.

### ***Our ONA/SHMC bylaws state:***

*The Executive Committee shall be composed of elected or appointed ONA members in good standing and act as a steering committee to conduct the day-to-day business of the SHMC-ONA.*

*The SHMC-ONA Executive Committee shall consist of nine (9) members. The Executive Committee members shall elect the Chairperson and Vice-Chair and any other officers as it deems necessary.*

*The term of office of all Officers shall commence on the fifteenth (15<sup>th</sup>) of March following the election and shall last until the next elections. Executive Committee members will be elected for one (1) contract period.*

Note: The current contract expires on March 15, 2019.
