Dear OSHP Members:

We are seeking nominations for the Sylvia J. Martin Outstanding Pharmacy Technician Award. The award was created in 1998 to honor the memory of Sylvia J. Martin, a pharmacy technician at Mercy Health Center in Oklahoma City. The award consists of a five-year Oklahoma Society of Health-System Pharmacists (OSHP) membership, a plaque, and recognition at the OSHP Annual Meeting.

The Sylvia J. Martin Outstanding Technician Award nominee must have a current Oklahoma pharmacy technician permit and at least one letter of recommendation signed by a minimum of two nominators or two letters of recommendation from separate nominators. At least one of the nominators needs to be a Registered Pharmacist in Oklahoma; the second could also be a pharmacist, another health care professional, or an administrator who has worked with the technician. It is preferred that the nominee be an OSHP member. There may only be one nomination from an institution annually. Nomination forms and information may be found on the OSHP web site, www.oshp.net.
