

My name is Jhanalyn Blount and I am running for International Vice Justice. I currently serve as the Assistant District Justice for Arkansas in District VIII. I joined P.A.D. as a pre-law member at Wingate University. While at Wingate, I served as Justice of the chapter. I maintained active membership in P.A.D. when I attended the University of Arkansas at Little Rock Bowen School of Law: I served as the 1L representative; as a 2L I served in the role of Vice Justice; and as a 3L I served as Justice. At Bowen, I helped continue our tailgate for Razorback football in Little Rock as our signature event, and even got Themis as one of the sponsors. I also helped to create a fundraising and social event, Zero K. The event benefitted a local organization in Arkansas called the Van. The Van works with the homeless population in Little Rock and started out as a mobile shower unit. We were able to raise money, give out door prizes, and get local bands to volunteer their time to play. For the past four years, I have served as the Assistant District Justice ("ADJ") in District VIII for Arkansas. As ADJ under Peter Scimeca, I have learned so much about Phi Alpha Delta - how it works, how much passion and pride is in this organization, and how supportive other people in this organization are with one another. In June of 2019, I felt honored to participate in P.A.D. Day at the Supreme Court.

I will bring a willingness and desire to work to make P.A.D. more inclusive by pushing the core value of diversity. I believe the organization does well with other core values but falls short when it comes to diversity. Becoming more inclusive means being intentional about diversifying membership from the pre-law level up to the alumni level. So much so that I have also continued that endeavor by serving as a member of the Better Community Development board, The Young Alumni Board for the University of Arkansas at Little Rock Bowen School of Law, and the Junior League of Little Rock. I have used the skills I gained from serving as Vice Justice, such as being a liaison between members and the board as well as listening and watching to fully comprehend problems, offer valuable suggestions and implement viable solutions. I have learned to effectively manage my time by keeping a calendar to help navigate tasks. My time management skills enable me to ensure that I complete all membership requirements while maintaining a work/life balance. I have a proven track record of performing well under pressure and with time constraints.
