IRS DEDUCTIBILITY: None of these contributions is deductible as a charitable contribution under federal law. Contributions to political committees are not tax deductible. The portion of dues paid to the associations that are used for lobbying and political purposes are not tax deductible. For 2019, that portion is estimated to be 16%.

FEC DISCLAIMER: Federal law requires political committees to report the name, mailing address, occupation, and name of employers for each individual whose federal contributions aggregate in excess of \$200 in a calendar year. Federal law prohibits federal political committees from accepting corporate contributions. Contributions to political committees are strictly voluntary and no
