



# PRIOR AUTHORIZATION FORM

## Give Us Your Permission to Help the National Wooden Pallet & Container Association!

To build your industry PAC, we need to receive your company's authorization form. As a trade association, *PalletPAC* is required by Federal law to have your authorization before we ask for your financial support. This form does not obligate you to contribute to *PalletPAC* but does allow us to share information on political and legislative activities.

### What is the NWPCA PAC?

*PalletPAC* is the federally registered political action committee of the National Wooden Pallet & Container Association. NWPCA's *PalletPAC* is dedicated to supporting pro-industry candidates for the U.S. Senate and House of Representatives.

### Why should sign an authorization form?

*PalletPAC* ensures that NWPCA remains the primary voice in the electoral process by supporting candidates that understand our industry and issues. *PalletPAC* can directly support candidates who support your views on the issues vital to the future of your business. *PalletPAC* cannot solicit contributions without a signed authorization form.

### What is an authorization form?

Federal law mandates that we have your permission to keep you up-to-date on the NWPCA PAC's programs and activities. The authorization form does not obligate you to contribute to the PAC or limit contributions you may make to candidates or party organizations. The purpose of this form is to provide the authorization required by Federal law to allow *PalletPAC* to include the administrative and executive personnel of member companies in the political process through personal contributions. All contributions are voluntary and the suggested amount of a contribution is only a suggestion. The amount given by the contributor, or the refusal to give, will not benefit or disadvantage the person being solicited.

### Who can sign authorization forms?

Authorization can be given by any corporate representative if the member company has not given authorization to another association PAC.

### How can I help?

Federal law requires separate and specific consent for each year. By signing for the next five years, *PalletPAC* will not have to send you a notice every year to update our authorization. This will make it easier for us to communicate with you about our programs and events.

### Check one:

**Individual Authorization**

*PalletPAC* is authorized to solicit voluntary contribution from myself only as a member of the executive and administrative personnel of my company for the years listed below.

**Corporate Authorization**

*PalletPAC* is authorized to solicit voluntary contributions from the executive and administrative personnel of my company for the years listed below.

*PalletPAC* is authorized to solicit for the years listed below. Similar authorization has not and will not be given to any other trade association PAC for any year authorized below. Federal law requires us to report the name, address, occupation and name of employer for each individual whose aggregate contributions exceed \$200 in a calendar year.
