Greetings,

We are heartbroken by recent events in Minneapolis and the surrounding communities while also being proud of the overwhelmingly peaceful demonstrations and the strong, community-led network of mutual aid and civic engagement that has emerged. Much of what people are seeing day-to-day reflects residents, volunteers, observers and neighbors supporting one another.

The MHQ office is headquartered in Downtown Minneapolis, and we have continued to operate without interruption or incident, with our full team in the office at least weekly.

While demonstrations and public gatherings have occurred at specific moments and locations, Minneapolis continues to successfully host meetings, conventions and large-scale events successfully. The Minneapolis Convention Center (MCC) and several downtown hotels have welcomed several major events in recent weeks, including the Twin Cities Auto Show, Minnesota School Boards Association meetings, the Minneapolis Boat Show, the AmeriCup Dance Championship and the U.S. Pond Hockey Championships with multiple downtown hotels serving as key partners in the attendee experience. Surrounding hotels, restaurants, cultural attractions and transportation infrastructure remain operational, supported by coordinated security, hospitality, and public safety resources.

- Bloomington, MN continues to be a safe and welcoming destination for visitors. Bloomington Minnesota Travel & Tourism remains in close communication with hotel and hospitality partners and are seeing only minimal impacts, with no major business disruptions in Bloomington.
- Visitor activity in Bloomington continues to operate as normal, and Bloomington is leading the state in hotel occupancy.
