Bridging the Intention-Action Gap in Legacy Giving

Tracy Malloy-Curtis, JD, Director of Legacy Giving, Mal Warwick Donordigital

The intention-action gap – the difference between what someone says they will do and what they ultimately do – is an issue across many areas of human activity. Can we as fundraisers help bridge it with respect to legacy gift completion? Many organizations have been successful at generating a significant and growing pool of donors who share an interest in legacy gifts. But they soon learn that intention or interest does not always lead to action.

We will discuss:

- 1. The true role of a fundraiser/an organization in soliciting or closing a legacy gift
- 2. How fundraisers overestimate their ability to "close" legacy gifts
- 3. Why the majority of legacy gifts continue to arrive without prior disclosure.

In our discussion, we will identify what fundraisers can control in the legacy giving process, what they can't, and explore how to apply this learning to better allocate time and resources.


