Maine Issues Report on Product Stewardship Programs

The Maine Department of Environmental Protection (DEP) recently released a report, "Implementing

Product Stewardship in Maine," as required under the state's product stewardship framework law. The report aims to evaluate the state's product stewardship programs and make recommendations for product stewardship in the state. PSI, along with more than 150 Maine residents and other state and national organizations, submitted comments during the public comment period that ended January 16. PSI expressed support for rigorously applying metrics to evaluate stewardship programs, but found that many conclusions in the DEP report were based on a flawed analysis and inappropriate use of data. PSI also suggested that the LePage Administration collaborate with the American Coatings Association on paint legislation, and open up discussion with other important stakeholders, such as Maine's local governments, businesses, and environmental groups. After releasing its report, ME DEP provided a letter clarifying some of the statements in the report.

EU SETS HIGHER WEEE COLLECTION TARGETS

The European Parliament has passed new rigorous e-waste collection targets under the WEEE (Waste Electrical and Electronic Equipment) Directive, which has been in effect since 2003. The new regulations require member states to collect 65 to 85 percent of their electronic waste by 2019. The updated law requires manufacturers to recycle bulky items, like washing machines, and mandates that larger stores accept small e-waste items from consumers while not requiring a replacement purchase. NWSMA Releases Product Stewardship Policy

The National Solid Wastes Management Association (NSWMA) recently released its first policy on product stewardship. A central aspect of the policy is that a successful product stewardship system requires shared responsibility among manufacturers, retailers, government, consumers and the private and public sector recycling and solid waste industries. NSWMA's recommendations for product stewardship programs include: designing legislation to be "cost-effective, innovative, efficient and result in enhanced environmental protection at no additional cost to taxpayers or consumers"; conducting lifecycle assessments before mandating product stewardship; and ensuring that programs exist in a competitive market without anti-trust immunity for product stewardship organizations. BATTERY COLLECTION INCREASED IN 2011

<u>Call2Recycle</u>, a PSI Sustaining Partner, recently announced a 13.1 percent increase in battery recycling in 2011 through its network of 30,000 retail, business, and municipal collection locations. Illinois, Pennsylvania, and Texas saw the highest growth, where municipalities outperformed retail and business collections with a 37 percent increase. In Canada, collections for rechargeable batteries grew by 17 percent, while collection grew by 157 percent for primary batteries. As of 2010, when Call2Recycle worked with PSI to develop a briefing document, Call2Recycle was estimating an overall rechargeable battery recycling rate of roughly 10% for North America.
