173RD PSI UPSILON CONVENTION MINUTES OF THE OPENING GENERAL SESSION FRIDAY, JUNE 17, 2016

AUDITORIUM HYATT REGENCY BELLEVUE BELLEVUE, WASHINGTON

Thomas T. Allan, IV, Theta Theta '89 called the 173rd Psi Upsilon Convention to order at 5:10 p.m. on Friday, June 17, 2016. On behalf of the Theta Theta chapter, Brother Allan welcomed the delegates to Washington, discussed the history of the Theta Theta chapter, its chapter house and its place at the University of Washington. He then appointed the following temporary officers of the 173rd Convention:

173rd Psi Upsilon Convention Minutes of the Closing General Session Sunday, June 19, 2016

membership as honorary brothers, therefore be it

Resolved: Article IX, Section 11 of the Psi Upsilon Constitution is deleted and the

remaining Sections of Article IX shall be renumbered.

Whereas: From time-to-time the Executive Council grants honorary life membership to

certain of its retired members as a way to pay tribute to their exemplary

service to the Fraternity, and

Whereas: According such members voting rights implies the additional duties of an

active board member, therefore be it

Resolved: That the last sentence of Article III, Section 3 of the Psi Upsilon Constitution

be amended to read "All retiring members of the executive council who have served ten years or more may be elected honorary life members of the

Executive Council without voting rights.", and be it further,

Resolved: That the Executive Council and Convention continue to recognize an

honorary life member's service to the Fraternity and encourage all honorary

life members to stay involved with the Fraternity.

Mohan Hasan, Delta '17 presented the following resolution which passed unanimously.

General Resolution #16

Whereas: The Convention does not need to convene committees every year to conduct

the business of the Fraternity; and

Whereas: That time could be spent as a fraternity on educational, social and

philanthropic activities; and

Whereas: The Alumni Advisory Board was removed from the Psi Upsilon Constitution

at a prior Convention; be it

Resolved: That Convention Rule XI be changed to read: "The President may appoint

Standing Committees of four or more delegates, including undergraduates and alumni, to address pertinent issues facing the Fraternity, encompassing singly or in combination at least the following: awards, budget, future Convention sites, new business, nominations to the Executive Council, and

unfinished business.

Tyler Ryan, Lambda Sigma '17, presented the following resolution.

General Resolution #17

Whereas: Mental Health is an incredibly important topic in Higher Education; effects

include, but are not limited to, substance abuse, depression, anxiety, and

suicide: and

Whereas: Psi Upsilon has been affected in many ways, including the loss of

several brothers in recent years; and

Whereas: Brothers in the Lambda Sigma Chapter at Pepperdine have become involved

with the Out of Darkness Campus Walk by the American Foundation for Suicide Prevention and have encouraged and helped other Psi Upsilon

chapters become involved with this great cause; and

Whereas: Involvement in events like this can help raise awareness of mental health

issues and decrease the stigma surrounding mental health, therefore be it

Resolved: That Psi Upsilon Fraternity adopts the American Foundation for Suicide

Prevention and the Canadian Mental Health Association as philanthropic partners and encourages all chapters to participate in local Out of Darkness

Walks.

Chris Hannum, Lambda Sigma '17 moved to amend General Resolution #17 to change "encourages" in the resolved clause to "requires." The motion was duly seconded and defeated by a vote of six in favor and 45 opposed.

General Resolution #17 was then passed by a voice vote.

Madison Turkette, Purdue Colony '19 presented the following recommendation.

Recommendation #4

Whereas: The 173rd Convention thanks Ross Szabo for his informative and important

presentation on mental health; and

Whereas: These issues are very important and deserving of additional attention,

therefore be it

Recommended: That the Executive Council shall review the Psi Upsilon Membership

Program with the intent of including a mental health curriculum.

Connor Hess, Pi '17 presented the following resolution, which passed by a voice vote.

General Resolution #18

Whereas: Mental illness is one of the greatest challenges facing college students arising

from organic and situational stressors, and all too frequently leads to

depression, anxiety, substance abuse, and even suicide; and

Whereas: Psi Upsilon has been affected in many ways, including the loss of brothers

over the years; and

Whereas: Involvement in events like the programming presented during this year's

leadership institute can help raise awareness of mental health issues and

decrease the stigma surrounding mental health, therefore be it

Resolved: That Psi Upsilon fraternity shall require all chapters conduct a mandatory

mental health awareness week at a time of each chapter's choosing during

which each chapter shall host, promote, or support appropriate mental

health educational programming, ideally in partnership with college or university expert personnel.

Upon a motion duly made, seconded and approved unanimously, the $173^{\rm rd}$ Psi Upsilon Convention was adjourned sine die at 5:53 p.m.
