### INVITATION TO VOLUNTARY ASSOCIATIONS

#### INVITATION TO NOMINATE COUNCIL MEMBERS FOR SOUTH AFRICAN COUNCIL FOR THE PROPERTY VALUERS PROFESSION (SACPVP) IN TERMS OF SECTION 3(1)(a) OF THE PROPERTY VALUERS PROFESSION ACT, 2000 (ACT NO. 47 OF 2000)

You are cordially invited to nominate one or more persons for consideration and possible appointment as member(s) of South African Council for the Property Valuers Profession in terms of the Property Valuers Profession Act, 2000 (Act No. 47 of 2000). When nominating, consideration should be given to representivity in respect of race, gender, disability and geographical location.

The following should be noted:

1. Each Voluntary Association may nominate a maximum of four (4) persons. Each nomination must be submitted on a separate Nomination Form and be signed by a duly authorised representative, typically the President or Chief Executive (find the Nomination Form from [www.sacpvp.co.za](http://www.sacpvp.co.za)).
2. Nominees must be registered with South African Council for the Property Valuers Profession, in at least one of the following categories: Professional Valuer; Professional Associated Valuer or a specified category (**registration in the candidate category is expressly excluded in terms of section 3(1)(a) of the Act**).
3. Nominees appointed to the council may not serve for more than two consecutive terms of office.
4. The council will meet at least twice a year and will be supported by administrative staff. The period of office for the members is four years.
5. Nomination on the Nomination Form must include-
  - (a) details of the nominator and his or her signature;
  - (b) an indication that the nomination is in terms of section 3(1)(a), 3(1)(b) or 3(1)(c);
  - (c) details of the nominee and his or her signature;
  - (d) acceptance by the nominee and his or her signature;
  - (e) a declaration by the nominee stating that he or she is not disqualified in terms of section 6(1) of the Act and has not served on the council for two consecutive terms; and
  - (f) a brief curriculum vitae of not more than two pages.

6. Successful nominees will be appointed in their own right and will not represent their Voluntary Association.
7. Since the potential number of nominations is likely to exceed the number of vacancies on council by a significant margin, serious consideration will be given to the nominees with insight into matters concerning property or real estate (valuation), economics, statistics, finance, accounting, human resources, law, education and training, regulatory environment or safety and health of the public.
8. All nominees must be citizens of and ordinarily resident in South Africa.
9. All nominations, duly completed and signed, must be submitted to SACPVP at the address provided in this correspondence, by no later than the 18 May 2018 at 12h00. Incomplete nominations and nominations received after this date will not be considered.
10. SACPVP will establish a "Recommendation Panel" (in terms of rule 8 of the Rules for the Procedure of Nomination of SACPVP Council members) which will be responsible for recommending to Council the names of the nominees considered most suitable for appointment by the Minister. No member of the Recommendation Panel will be eligible for appointment to the council.
11. The Minister retains the discretion to appoint any person who may have been nominated but not recommended. Therefore, all names of all the nominees will be submitted to the Minister.
12. A non-citizen, unrehabilitated insolvent, person convicted of serious offences (excluding political offences), person found guilty of improper conduct and a person removed from an office of trust does not qualify to serve as a member of council.
