### REQUEST FOR PROPOSALS

The South African Council for the Quantity Surveying Profession was established in terms of the Quantity Surveying Profession Act, 49 of 2000 (“the Act”).

The Act requires the SACQSP to refer any matter brought against a registered person to an investigating committee. This process may conclude with a hearing before a disciplinary tribunal. If appointed, the successful applicants will be required to attend to the prosecution of registered practitioners.

The SACQSP therefore requires applicants to submit proposals setting out or containing the following:

- The applicant’s background and track record;
- List of proposed professionals to attend to the work, together with the curricula vitae of the proposed professionals;
- Examples of similar regulatory and administrative law work done in the past three years;
- Tax clearance certificates;
- Fidelity Fund Certificate.
- B-BBEE certificate.

Successful applicants will be required to conclude a service level agreement with the SACQSP, and will be appointed for a period of two years. Please note that work is not guaranteed and will be awarded at the SACQSP’s discretion. Appointments will only be formalized upon signature of a service agreement.
