- Must have five (5) years of economic development experience (please submit current resume/employment history).

Please provide no more than three (3) additional letters of recommendation.

### **Evaluation Criteria**

In a brief narrative, please comment on the achievements of the nominee you consider worthy of recognition. These should include the following:

1. Innovate activities initiated and/or implemented in support of economic development (30%)
2. Impact of efforts on the community (30%)
3. Involvement with SCEDA (15%)
4. Professional development (10%)
5. Personal traits/characteristics (10%)
6. Any additional comments to support the nomination (5%)
