Evaluation Criteria

In a brief narrative, please comment on the achievements of the nominee you consider worthy of recognition. These should include the following:

1. Innovate programs or activities initiated and/or implemented (25%)
2. Accomplishments of job responsibilities and obstacles overcome (20%)
3. Impact of efforts on the community (20%)
4. Involvement with SCEDA (15%)
5. Professional development (10%)
6. Personal traits/characteristics (5%)
7. Any additional comments to support the nomination (5%)
