

Henry E. Gibson Service Award Criteria

Purpose of the Award: To recognize and honor a member of the WEASC who has demonstrated outstanding service to the association through leadership and active participation in the WEASC programs.

Frequency of the Award: Annually or as Deserved

Eligibility for the Award: WEASC membership and outstanding service to the association for a period of at least 10 years

Entry Requirements: Any current member of WEASC wishing to nominate an individual for this award should submit an entry form and biographical information outlining his / her outstanding achievements to; Executive Director WEASC, 121 Executive Center Dr. Suite 115 Columbia, SC 29210

Nomination Procedure: The Awards Committee shall select by ballot the most deserving member who has rendered outstanding service and leadership to the association. All Nominators will be notified if their nominee has not been selected within that time. A candidate may be re-nominated. If the candidate is not re-nominated his / her name will be dropped from the list.

Submission Deadline: Nominations must be received by December 15th to be assured of receiving full consideration for the annual award. Special awards will be addressed on a case by case basis.

Presentation of the Award: The award will be presented at the annual WEASC Environmental Conference or at another appropriate event
